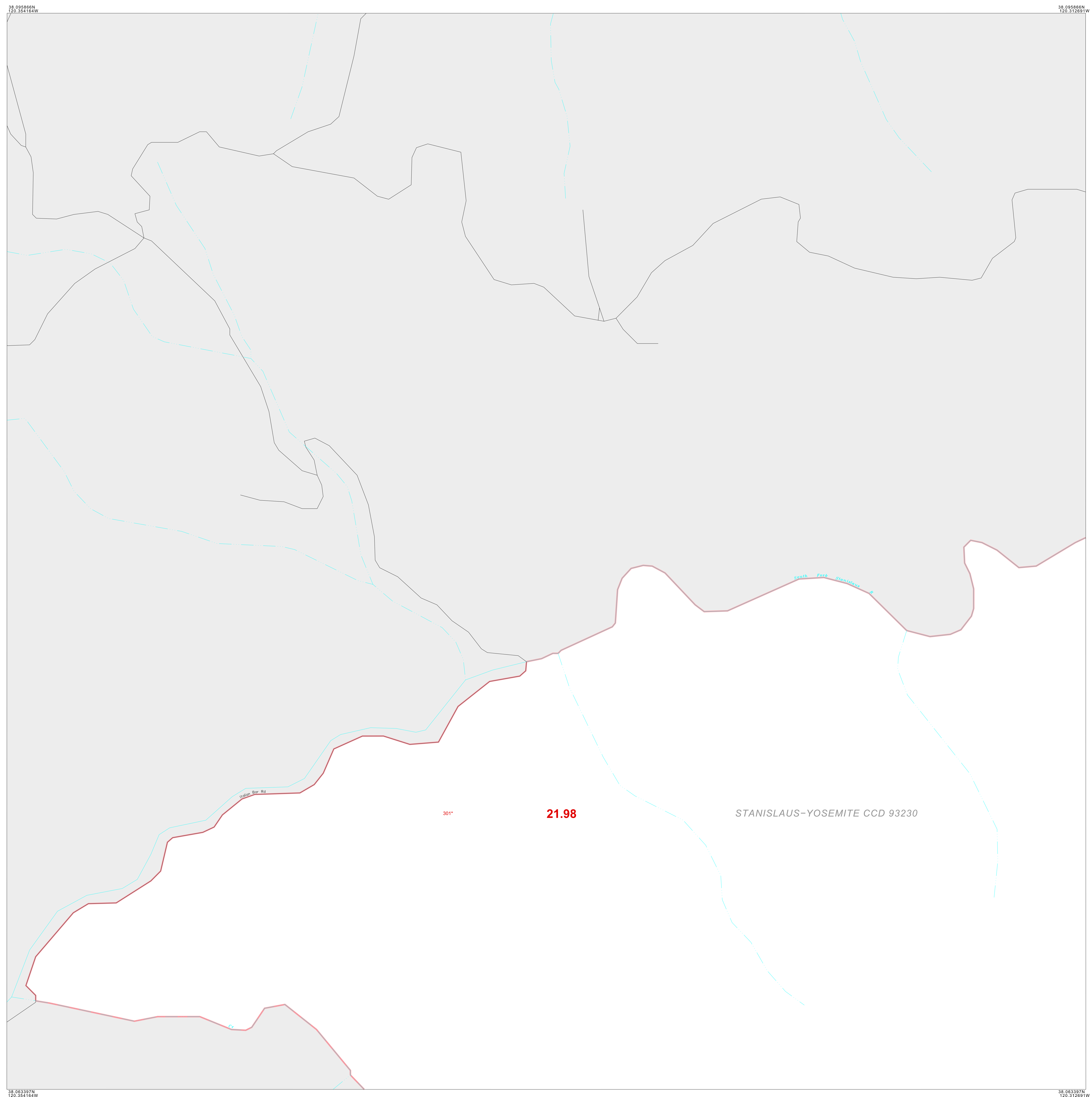


# 1990 COUNTY BLOCK MAP (RECREATED): TUOLUMNE County
