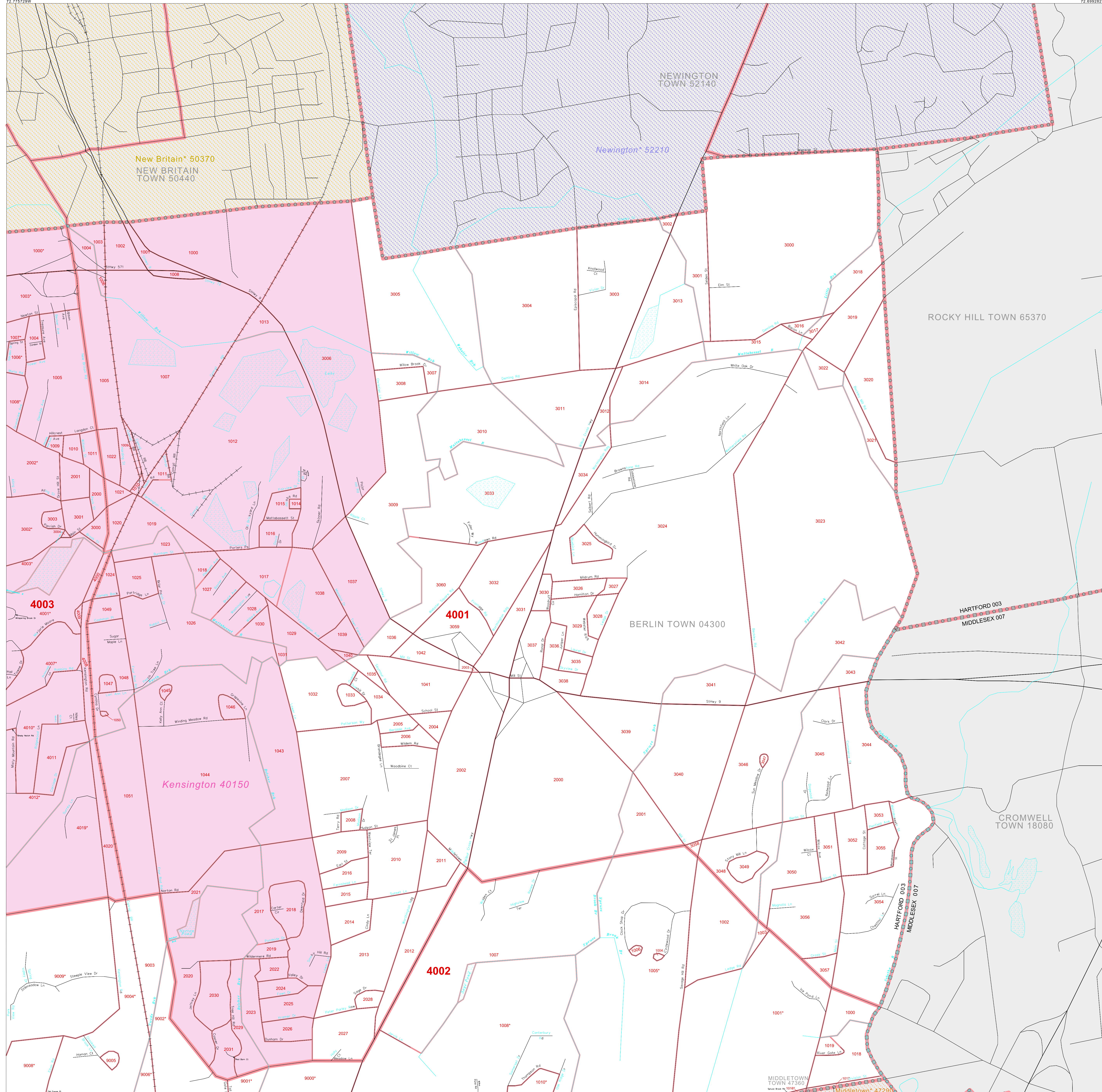


CENSUS 2000 BLOCK MAP: BERLIN Town
