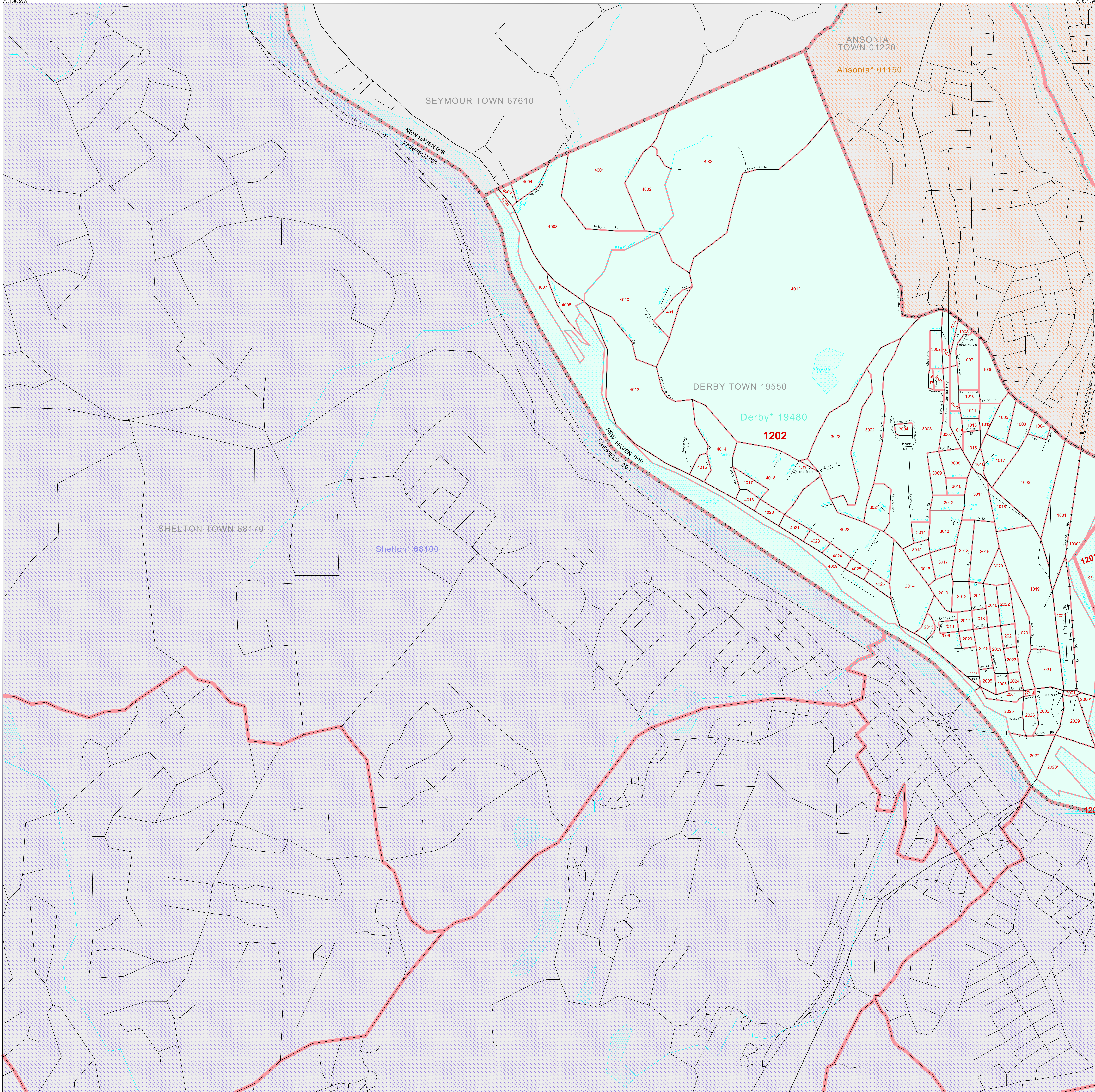


CENSUS 2000 BLOCK MAP: DERBY Town
