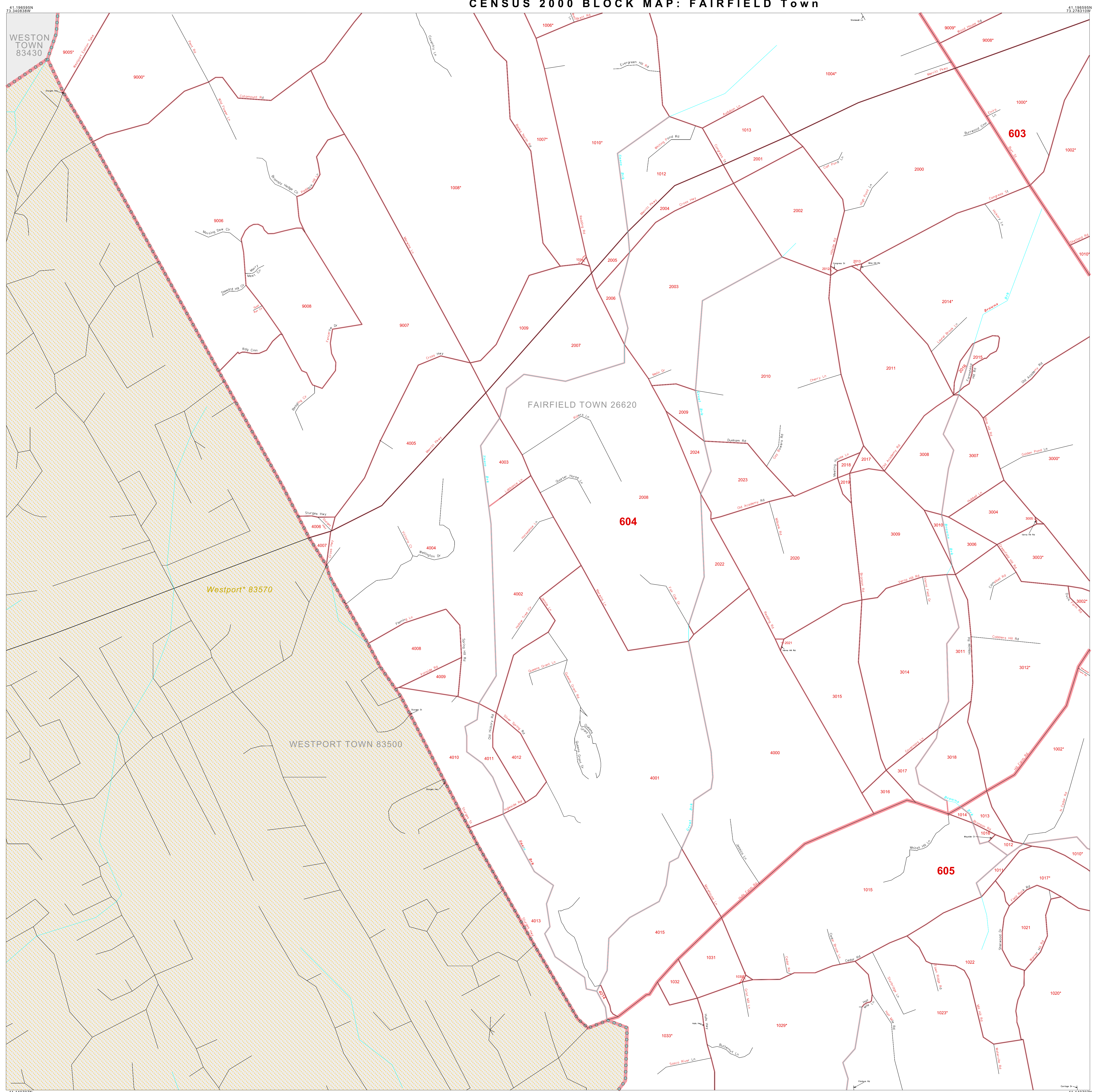


CENSUS 2000 BLOCK MAP: FAIRFIELD TOWN
