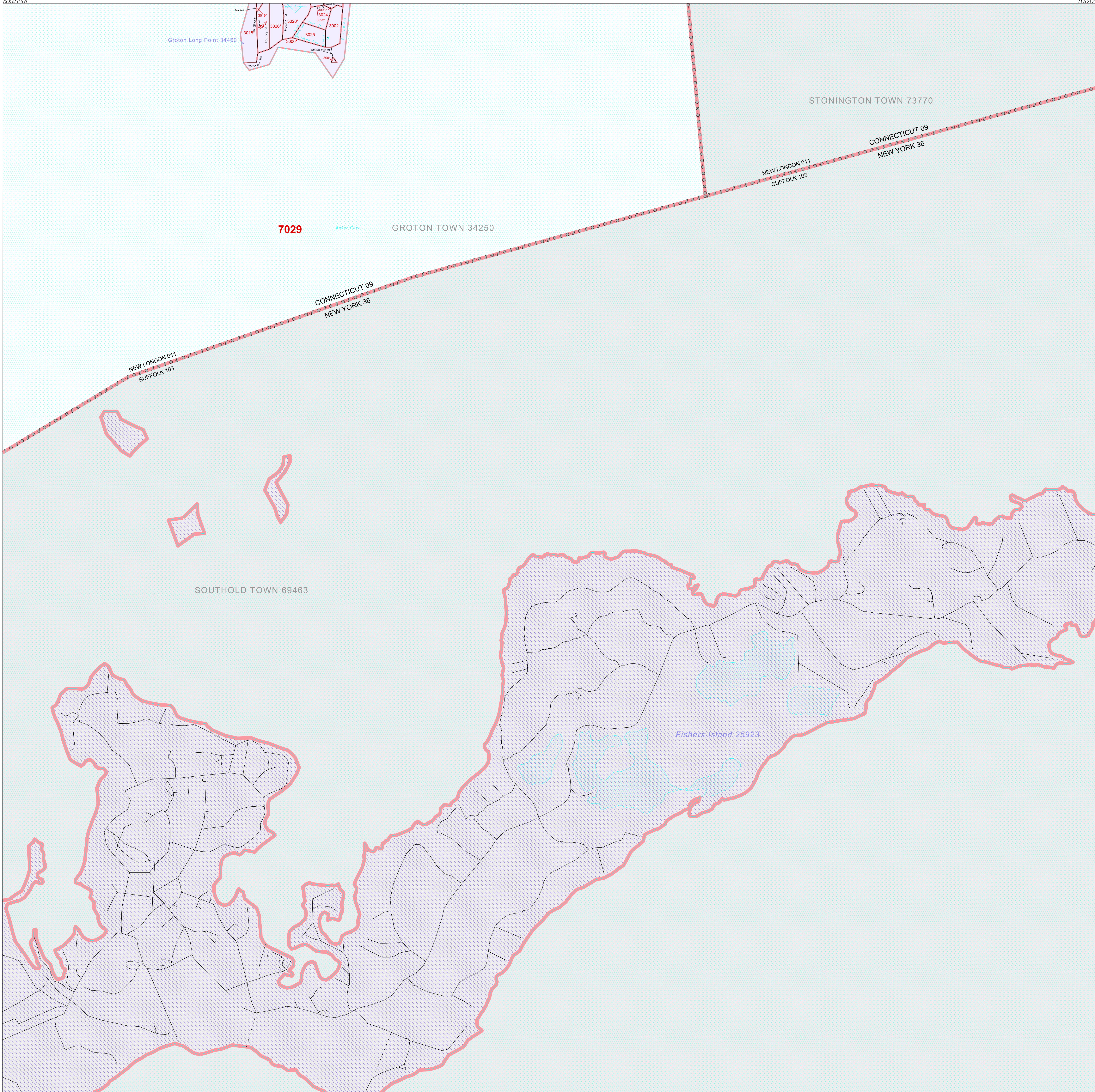


CENSUS 2000 BLOCK MAP: GROTON Town

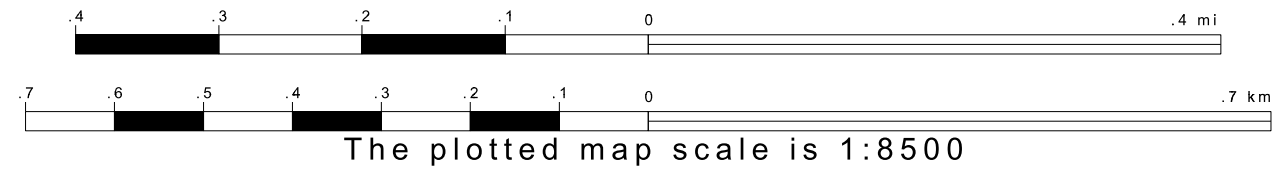
