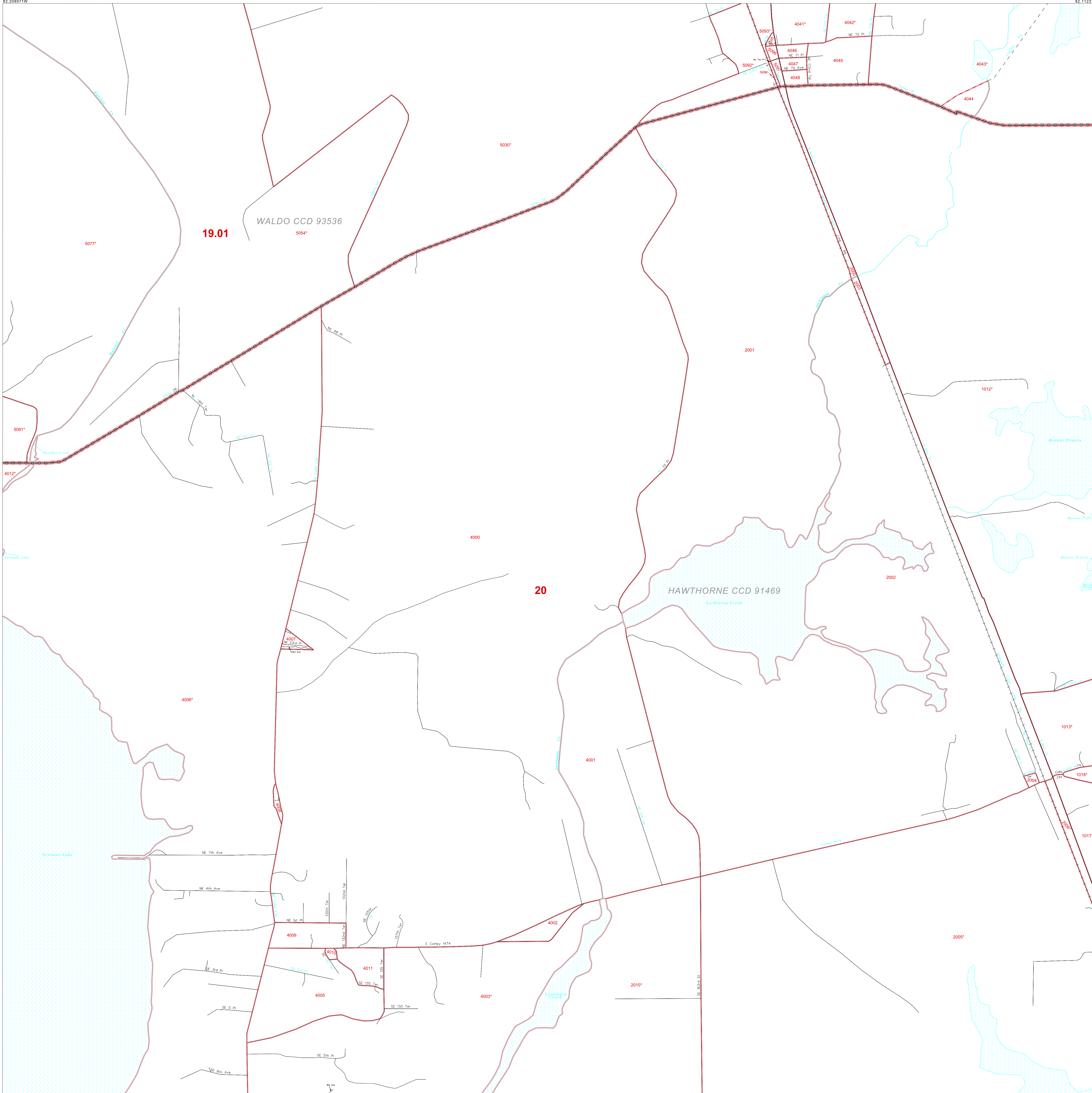


CENSUS 2000 BLOCK MAP: ALACHUA County
