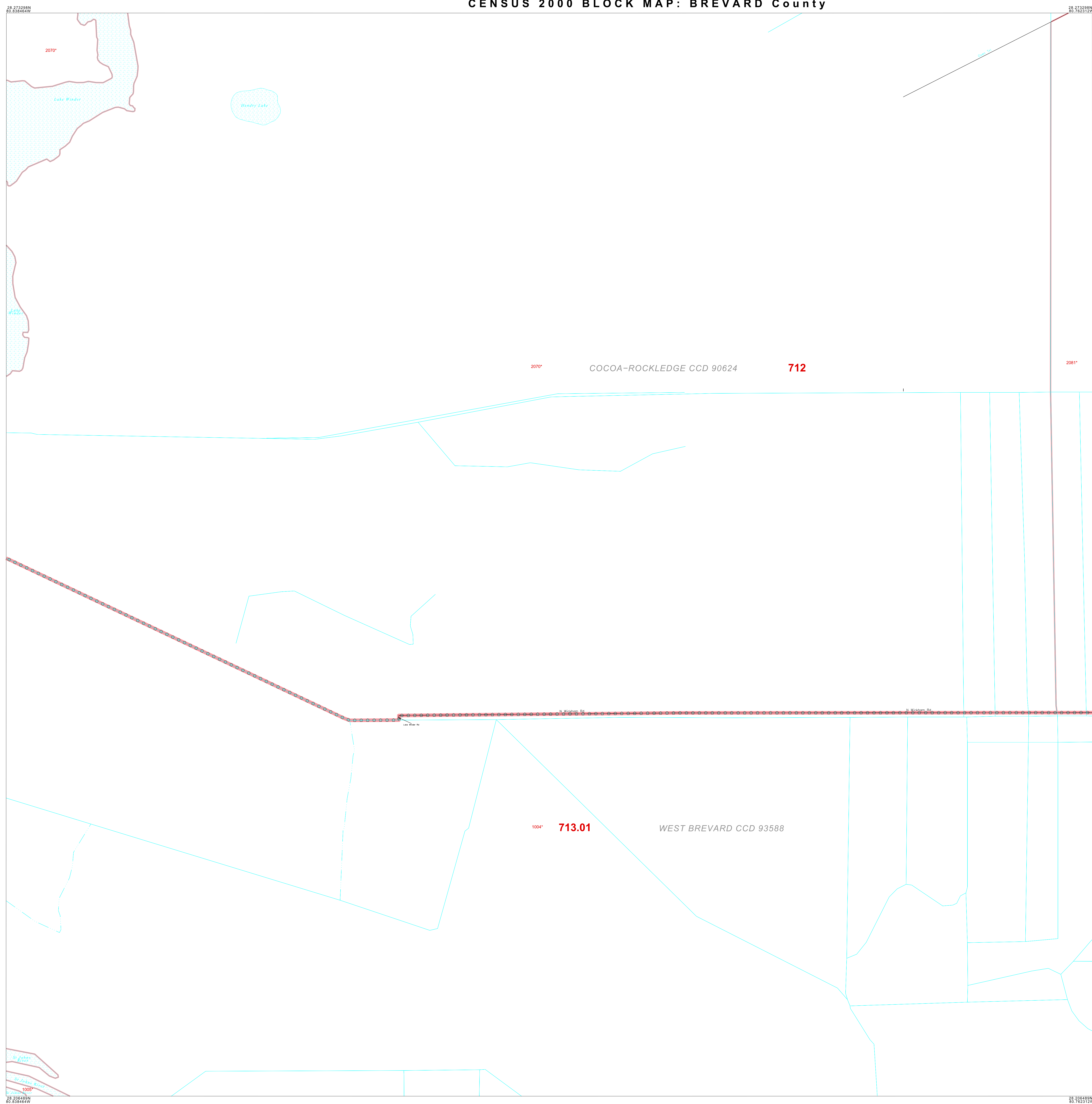


CENSUS 2000 BLOCK MAP: BREVARD County
