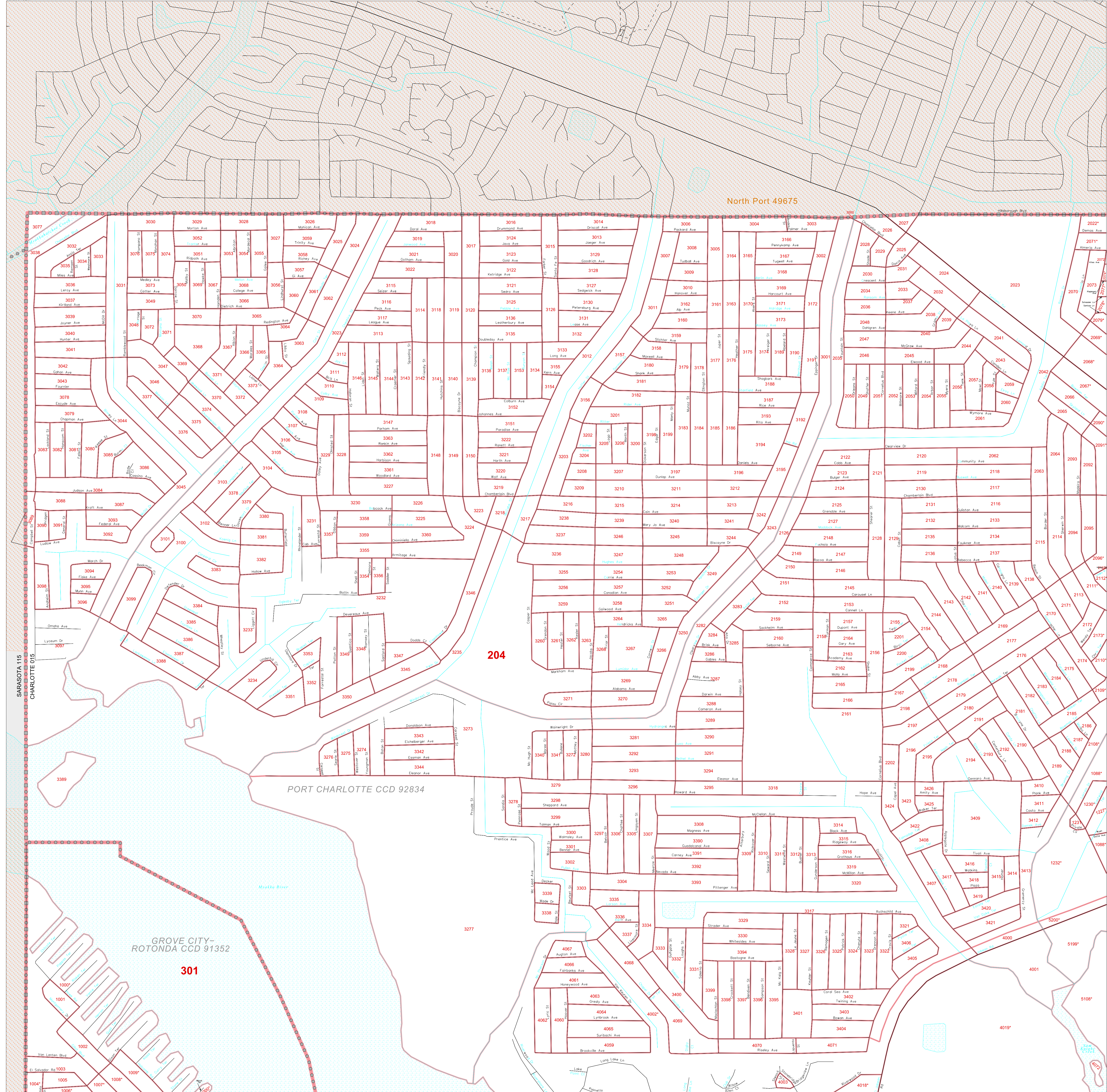


CENSUS 2000 BLOCK MAP: CHARLOTTE County

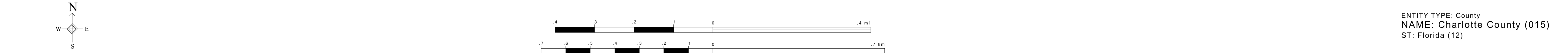
