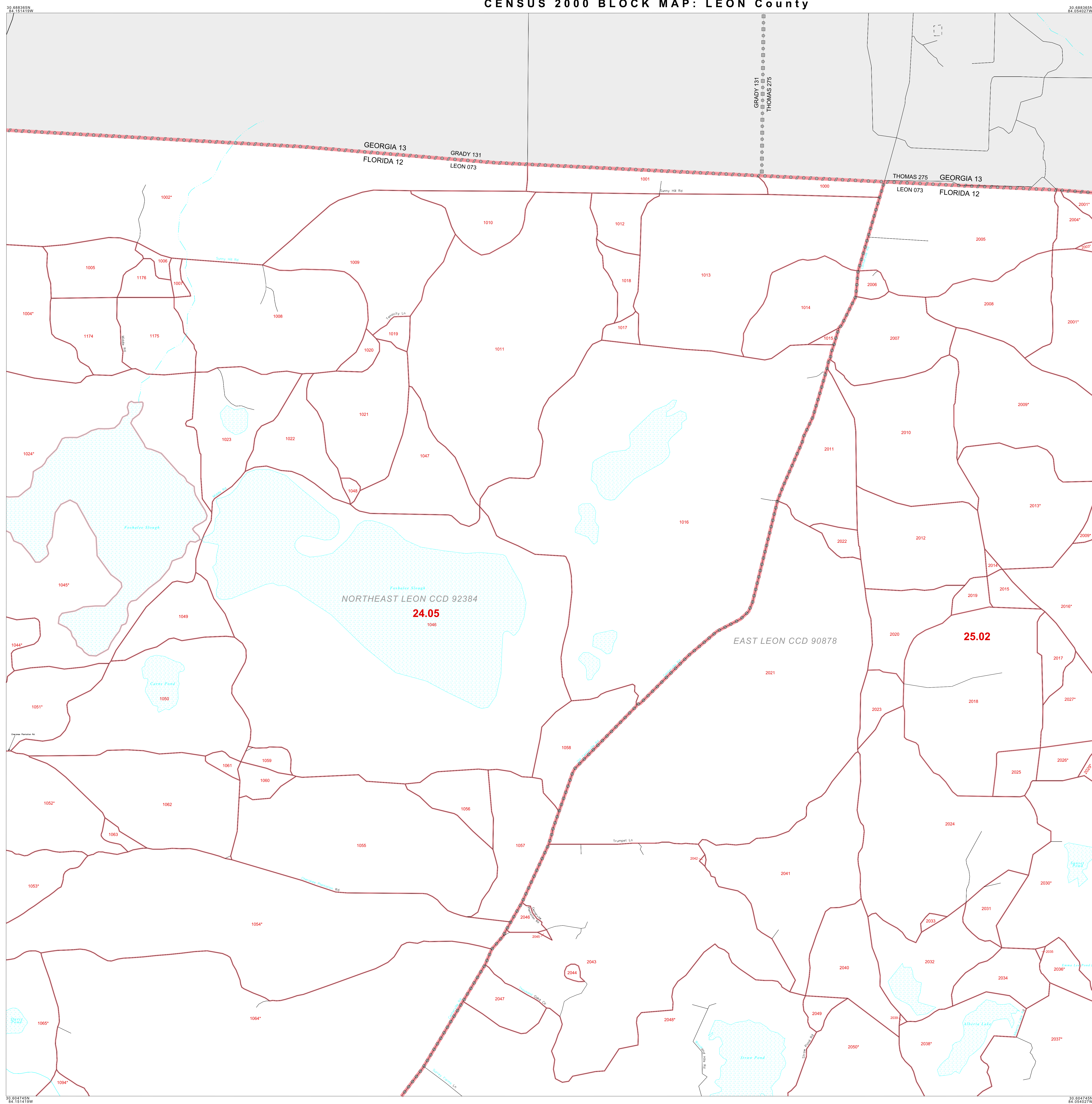


CENSUS 2000 BLOCK MAP: LEON County
