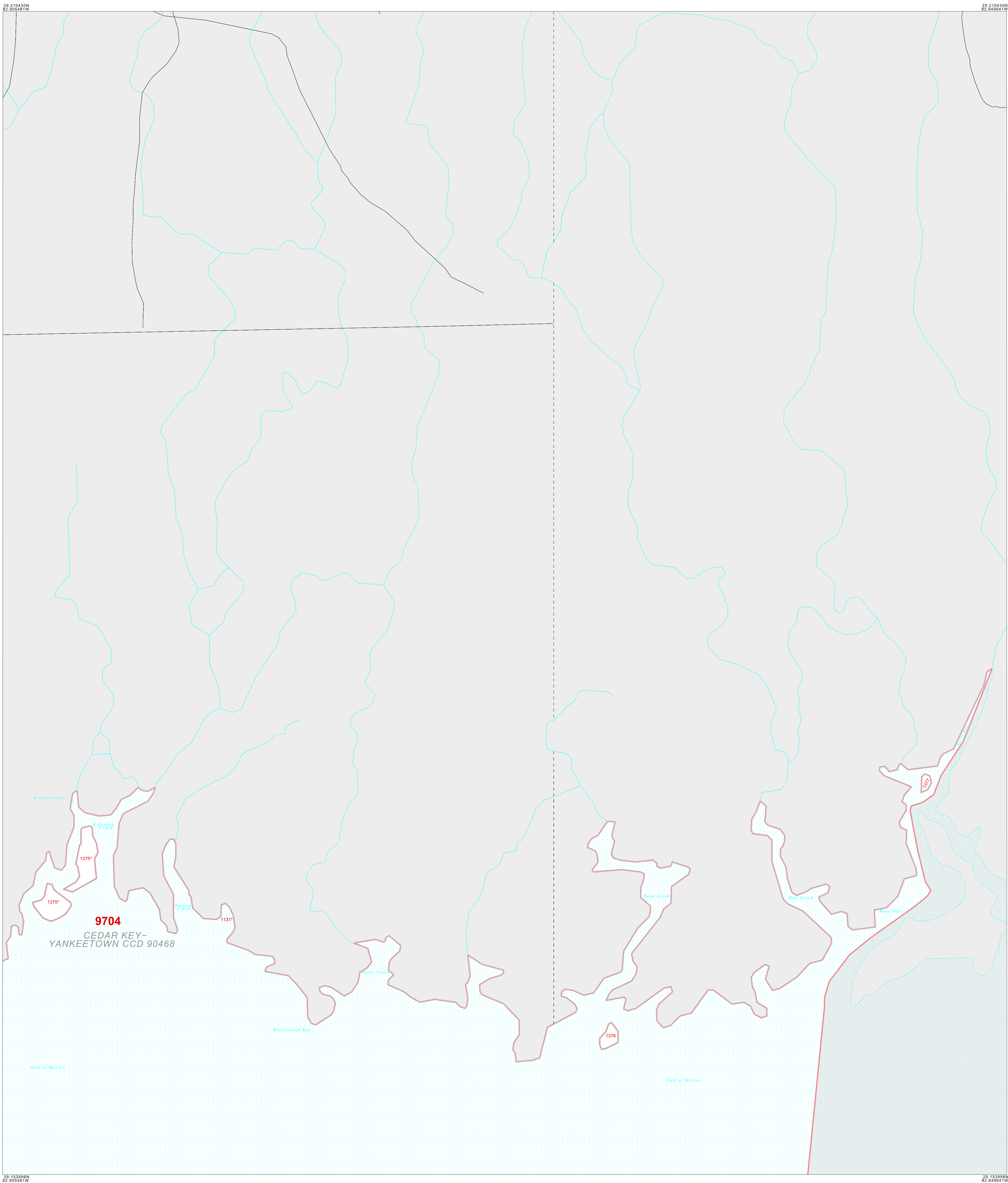


CENSUS 2000 BLOCK MAP: LEVY County
