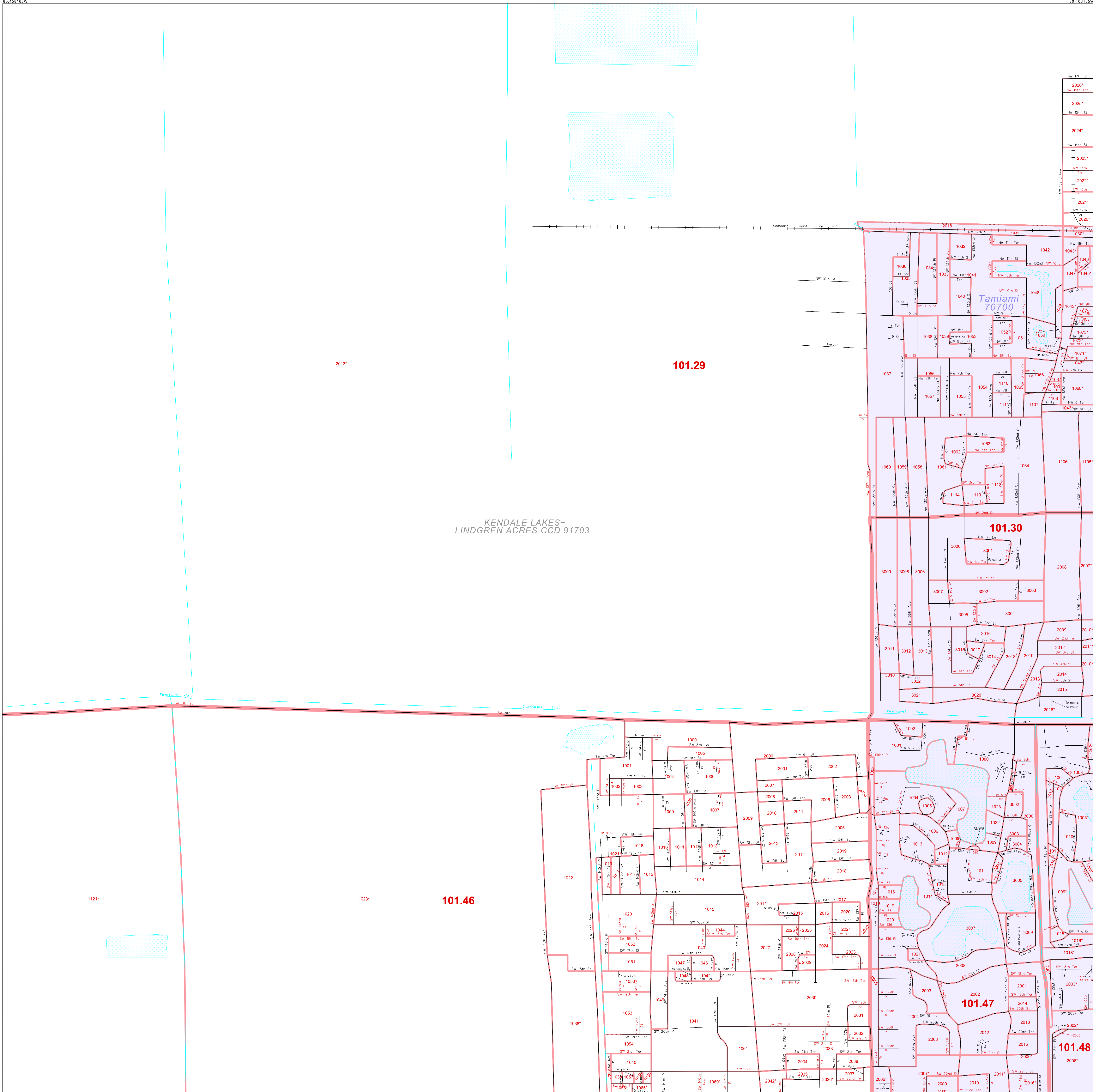


CENSUS 2000 BLOCK MAP: MIAMI-DADE County

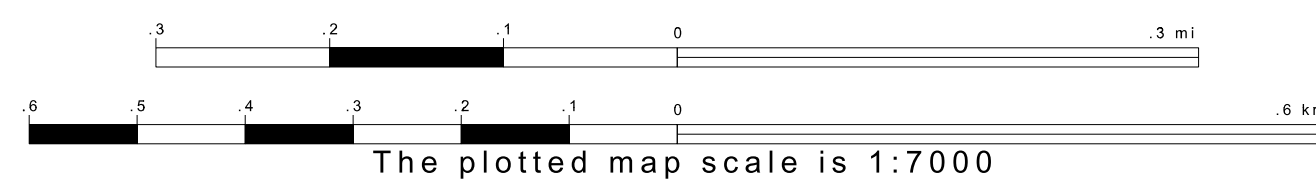

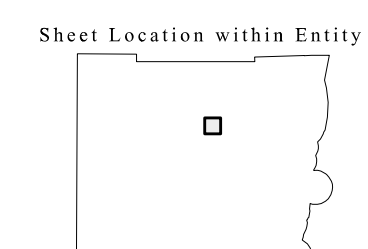
