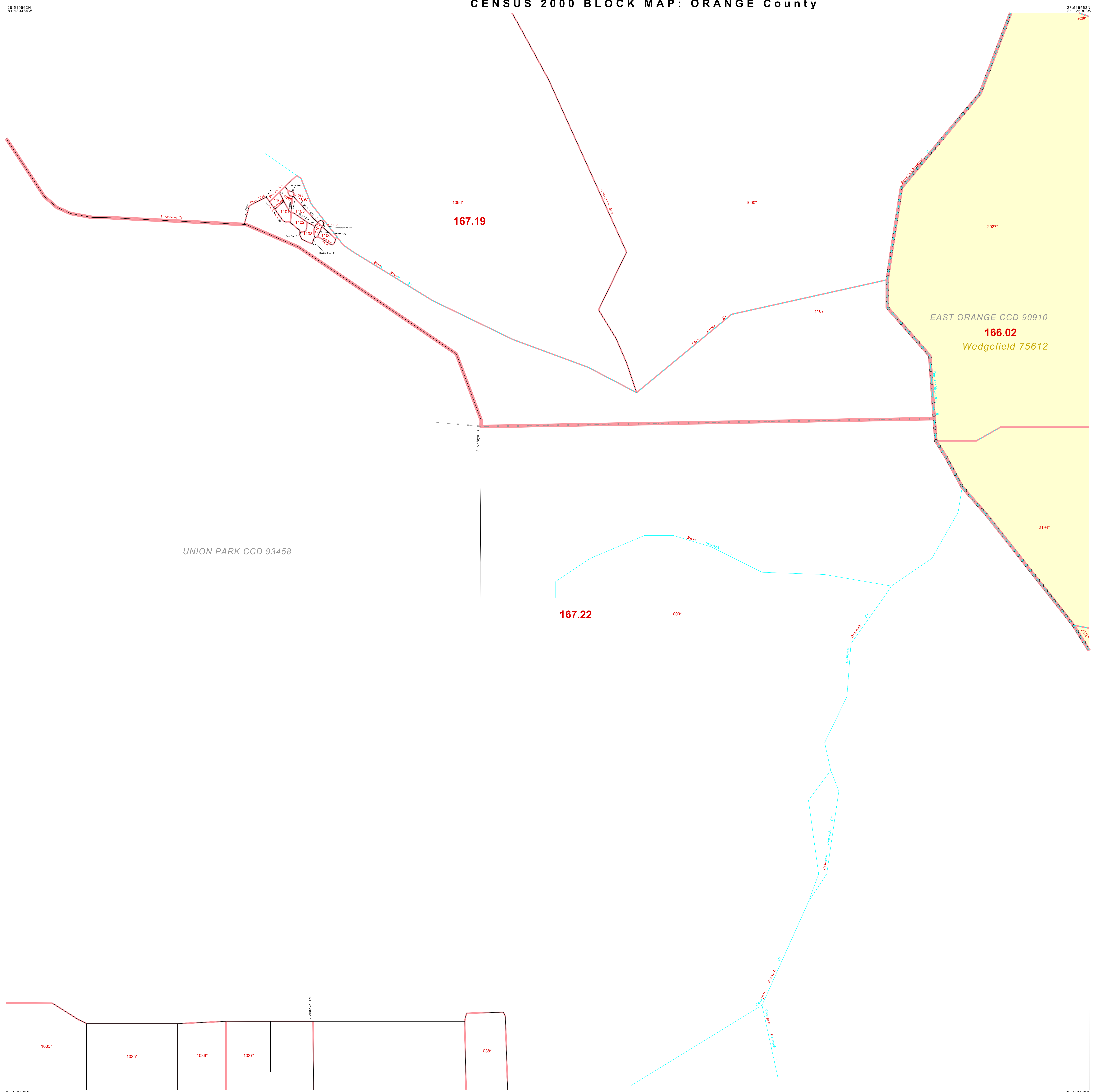


CENSUS 2000 BLOCK MAP: ORANGE County
