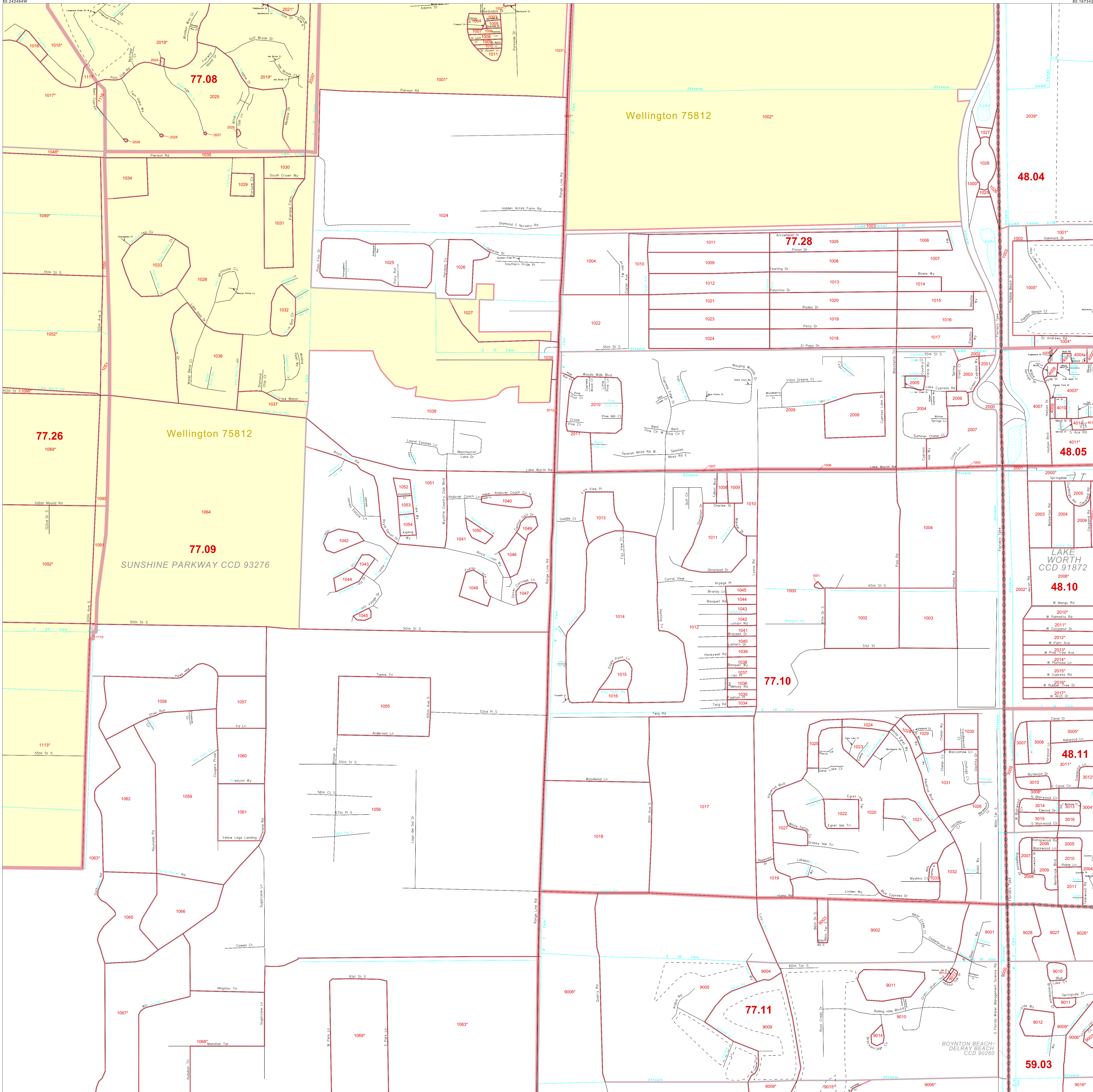


CENSUS 2000 BLOCK MAP: PALM BEACH County

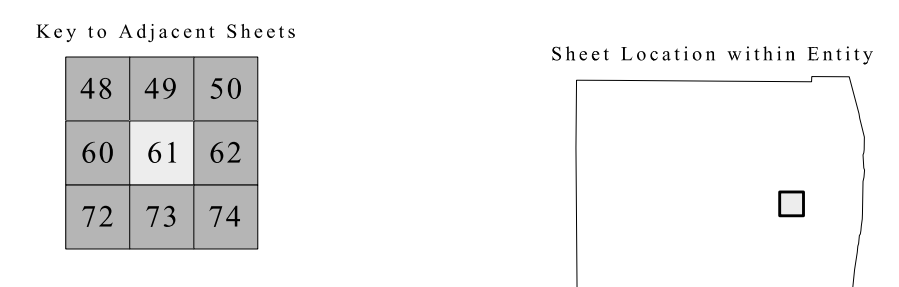
