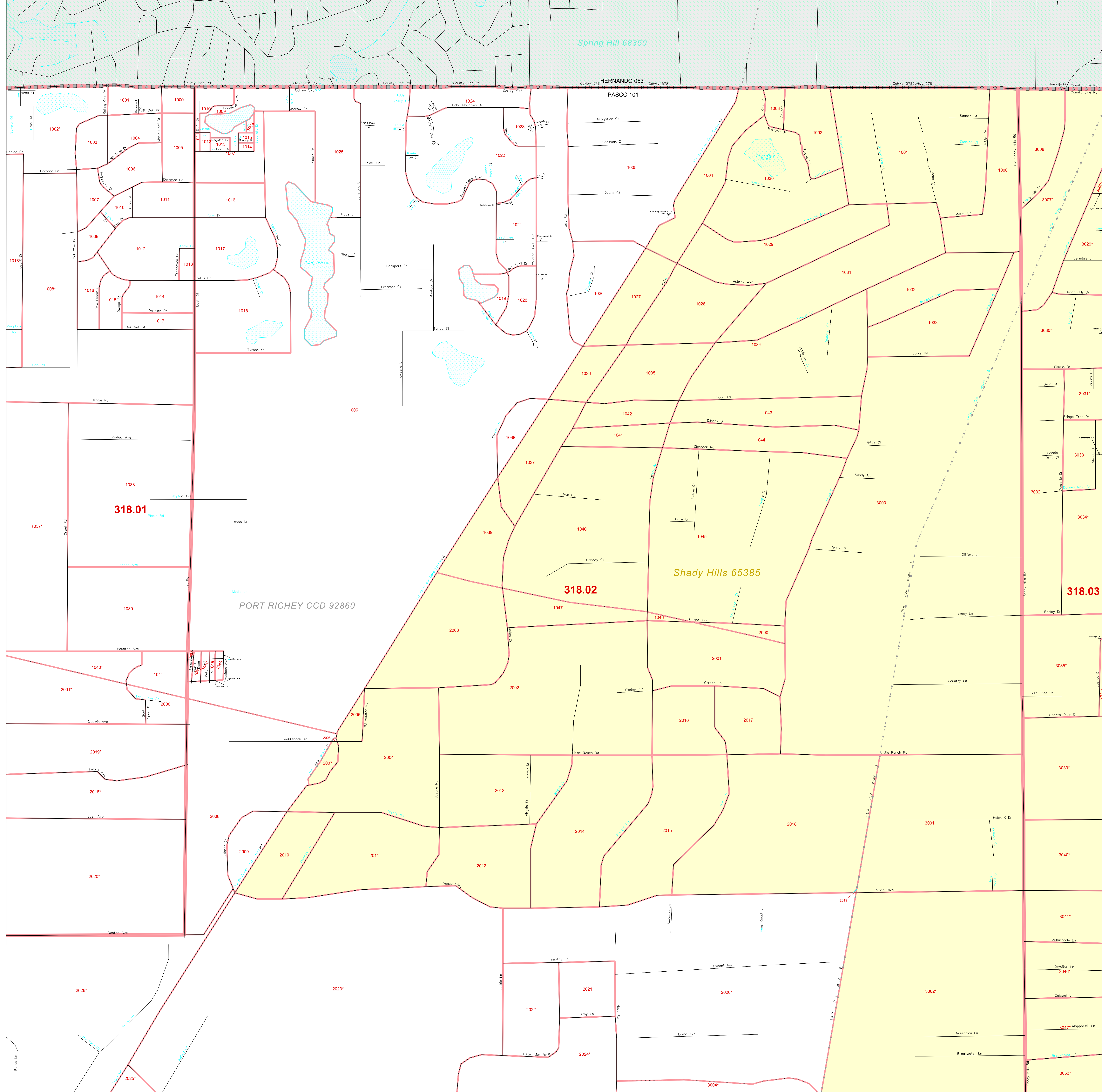


CENSUS 2000 BLOCK MAP: PASCO County

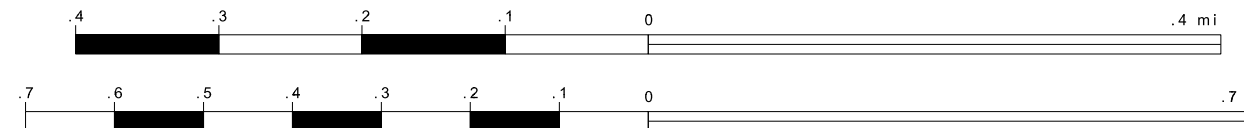
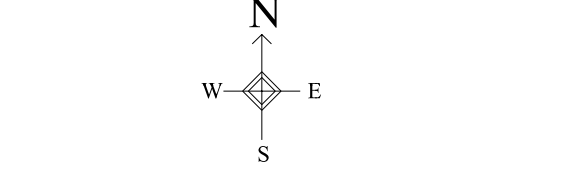

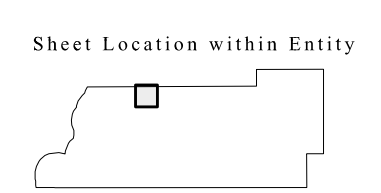
