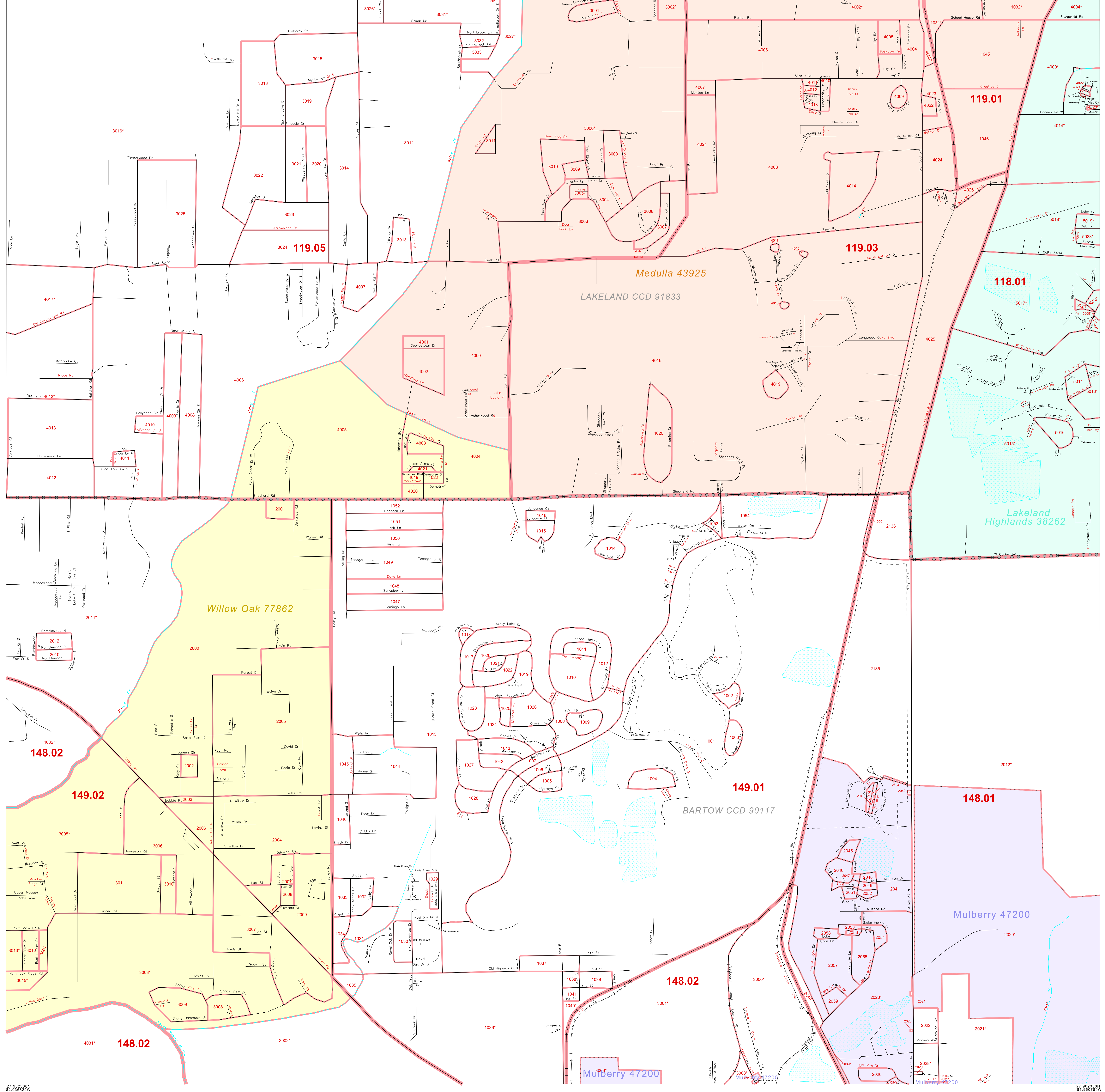


CENSUS 2000 BLOCK MAP: POLK County

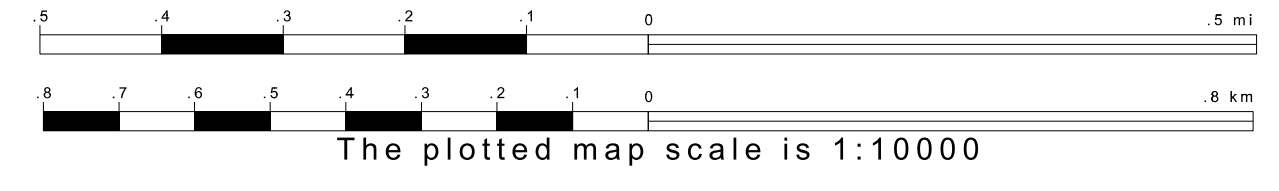
