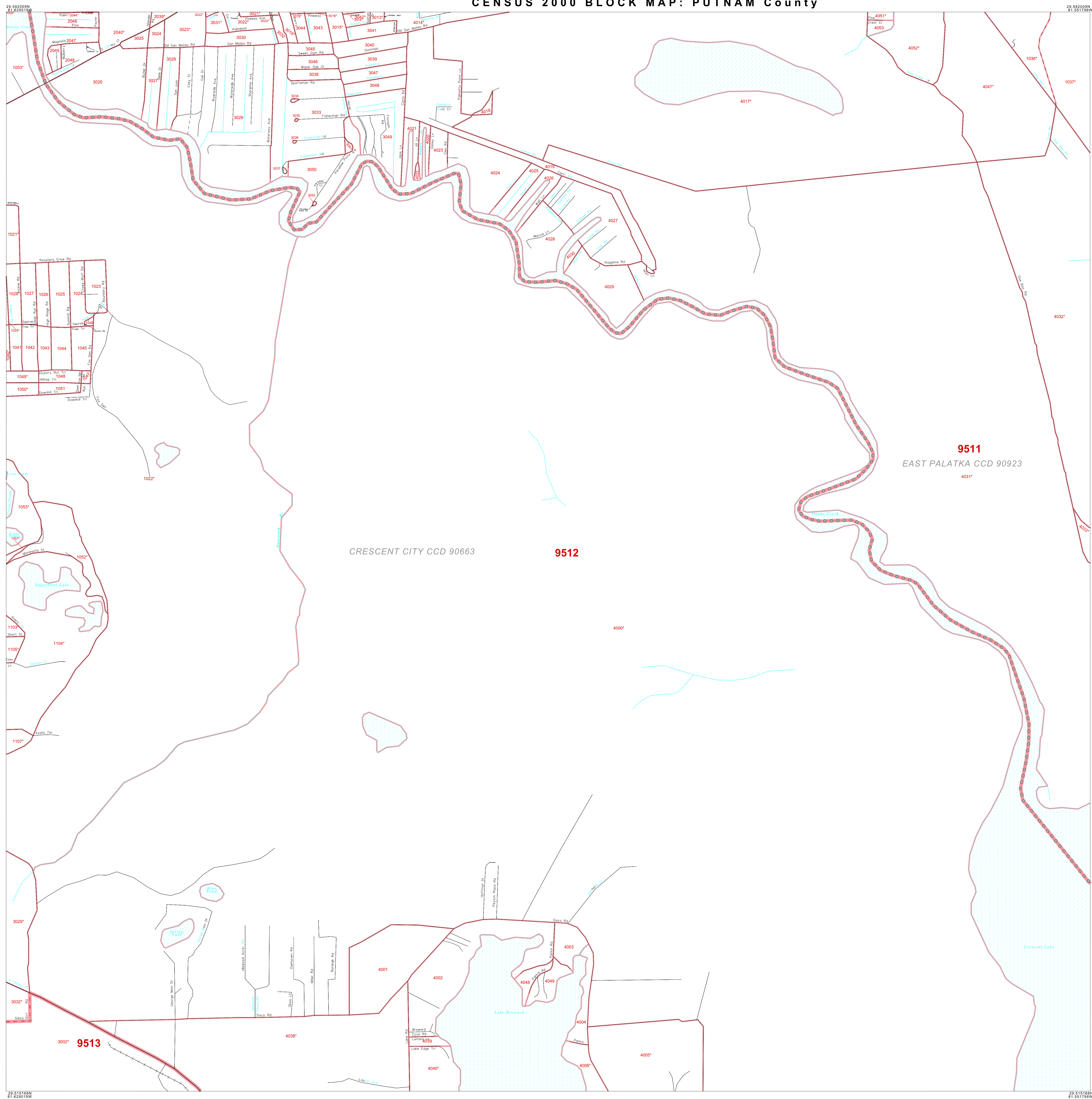


CENSUS 2000 BLOCK MAP: PUTNAM County
