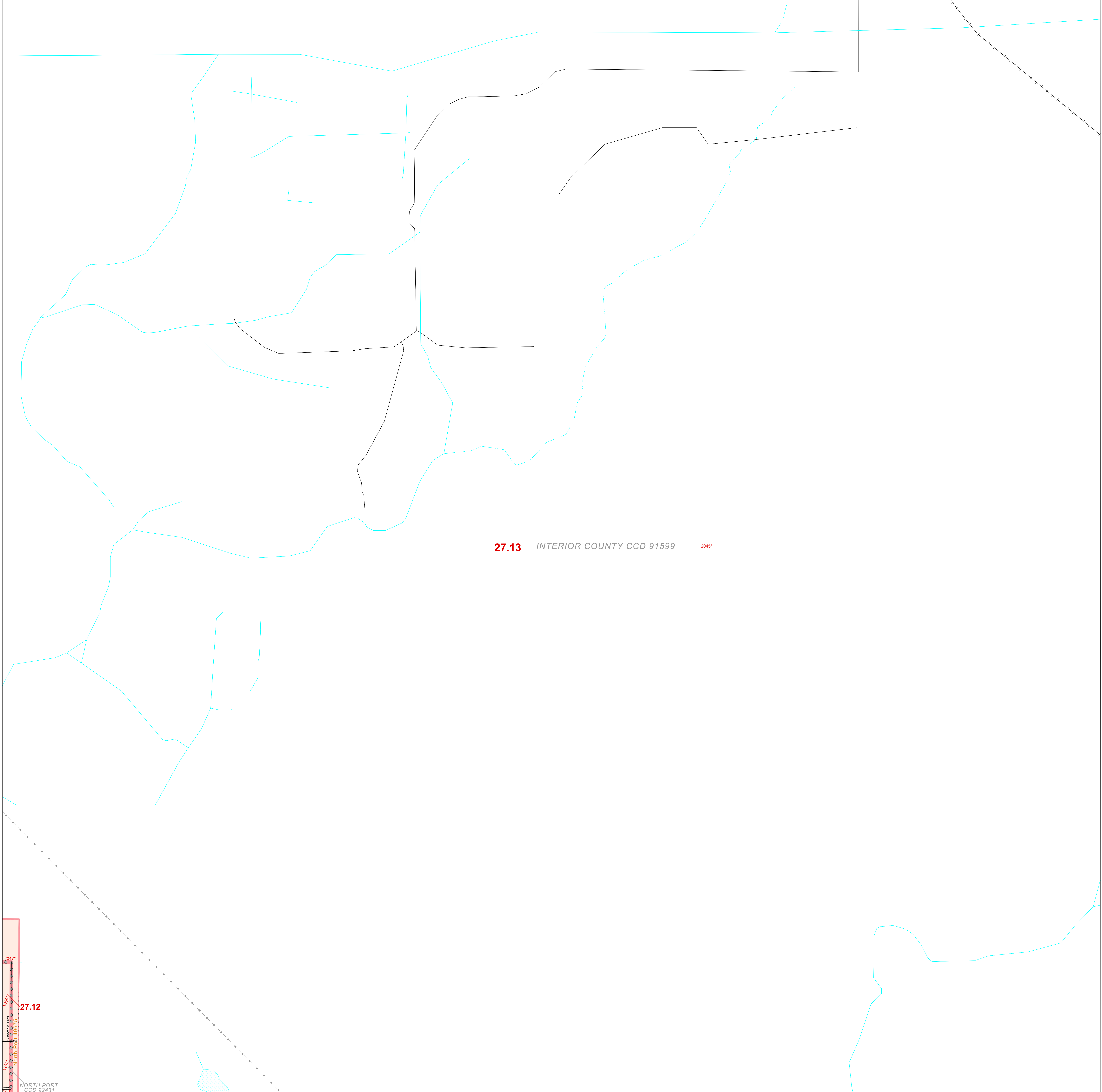


CENSUS 2000 BLOCK MAP: SARASOTA County

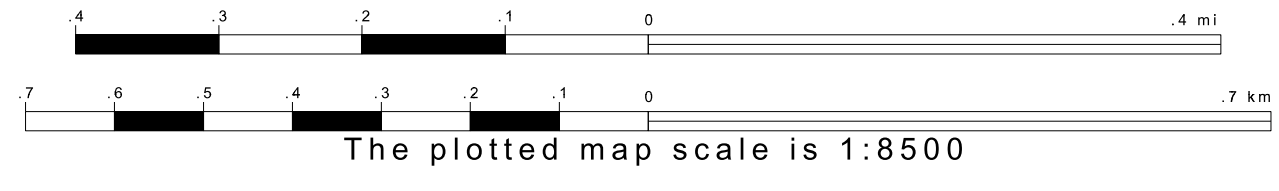
