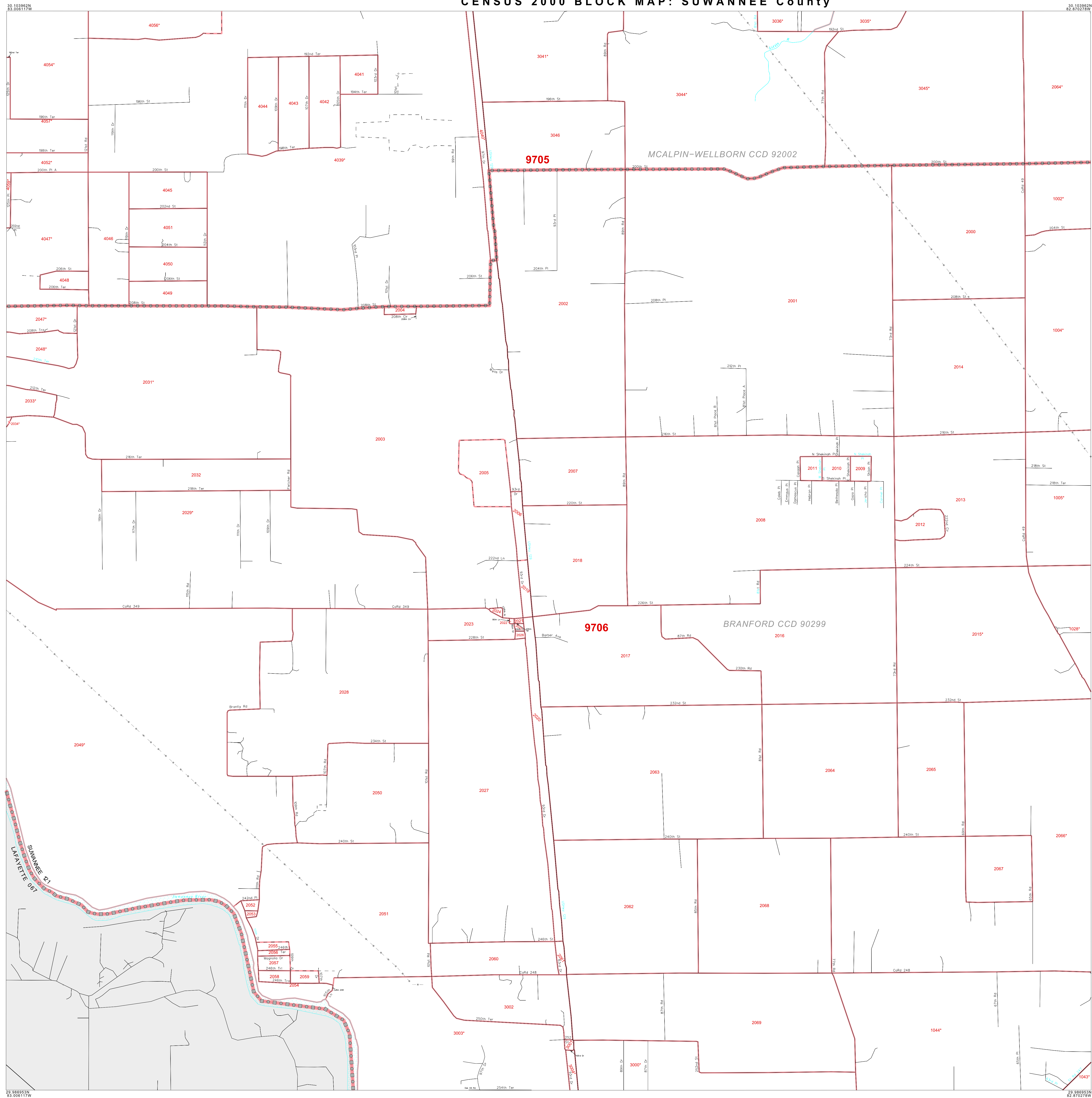


CENSUS 2000 BLOCK MAP: SUWANNEE County
