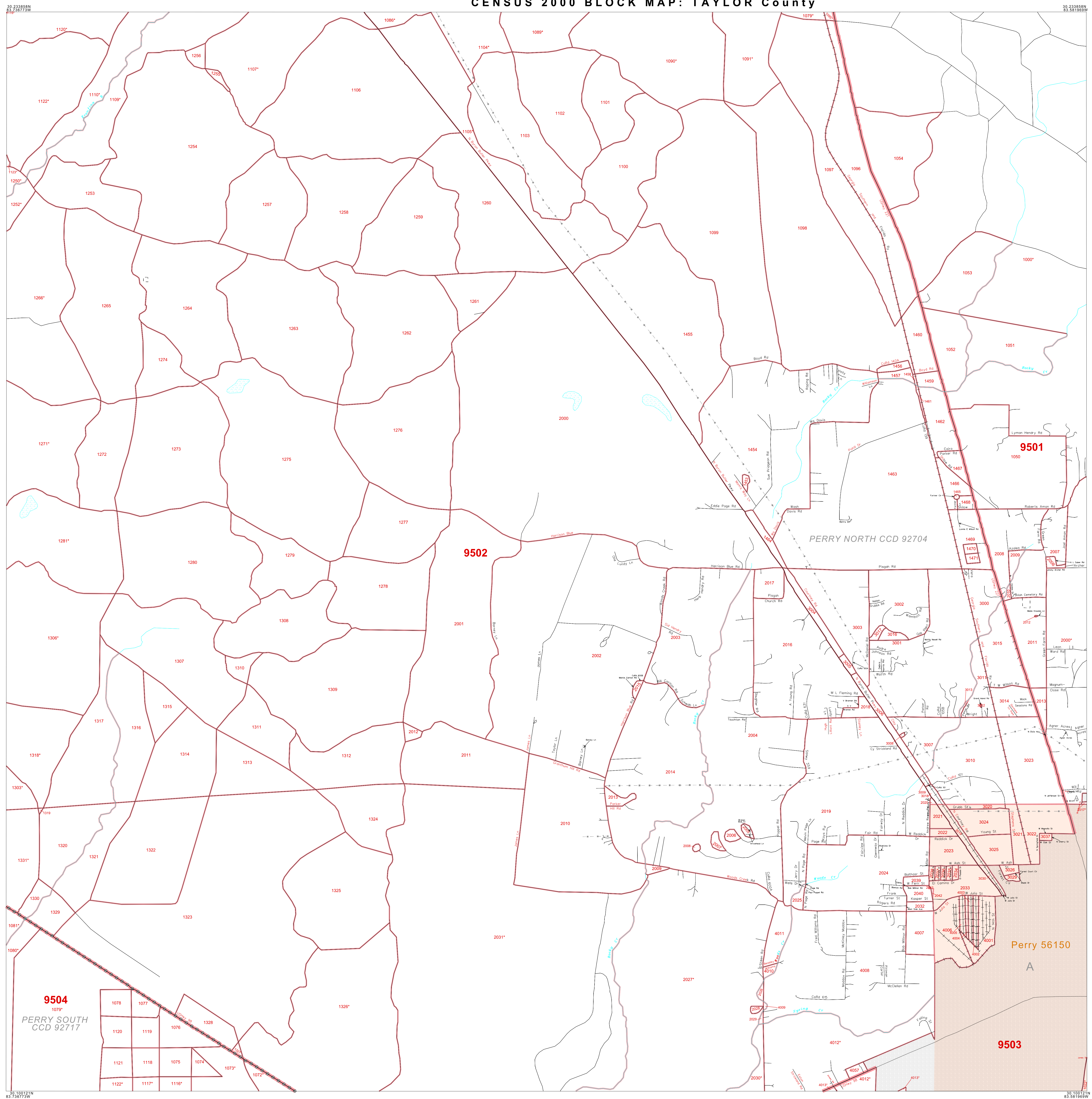


CENSUS 2000 BLOCK MAP: TAYLOR County
