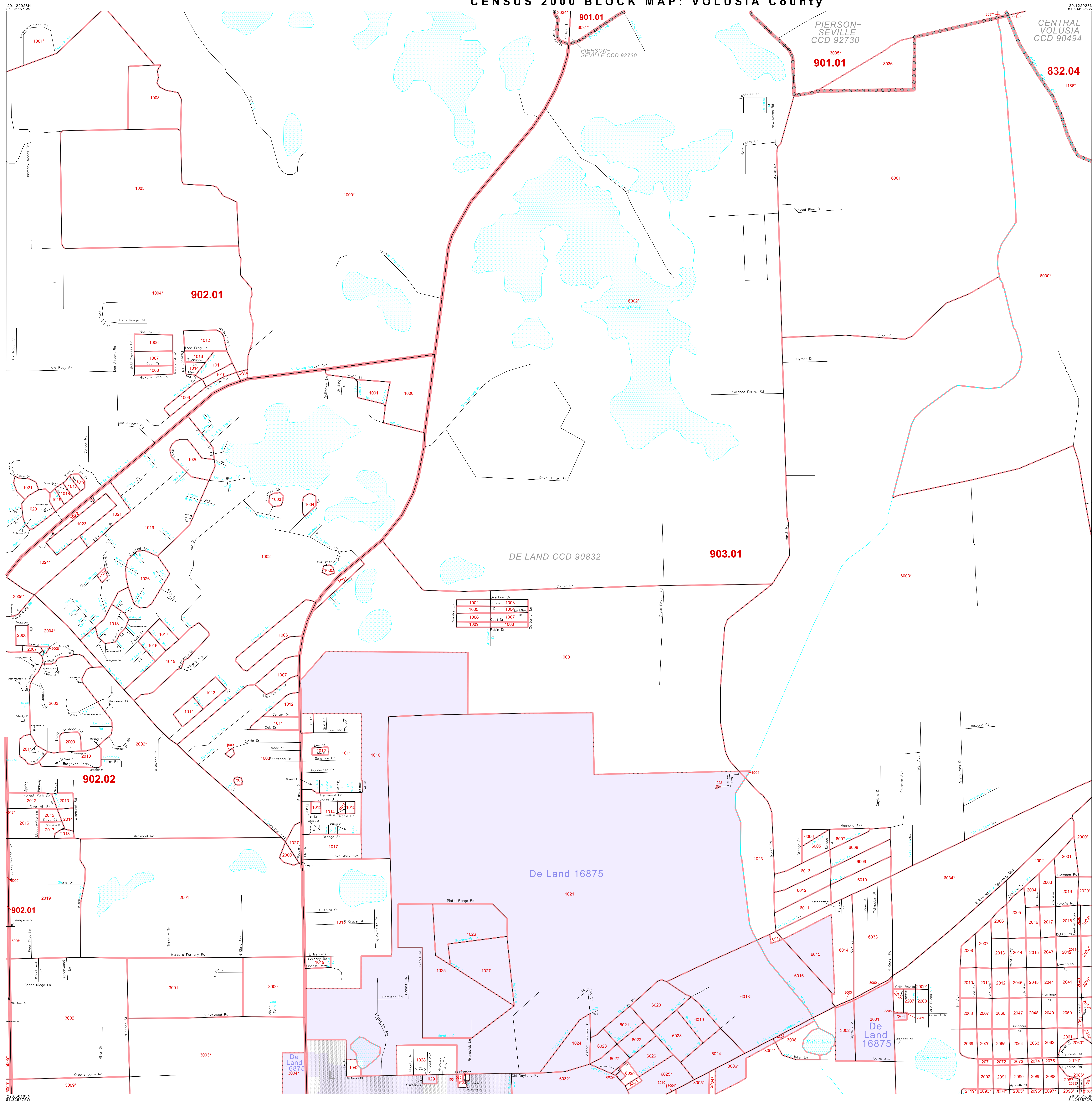


CENSUS 2000 BLOCK MAP: VOLUSIA County

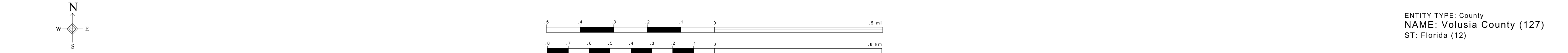
