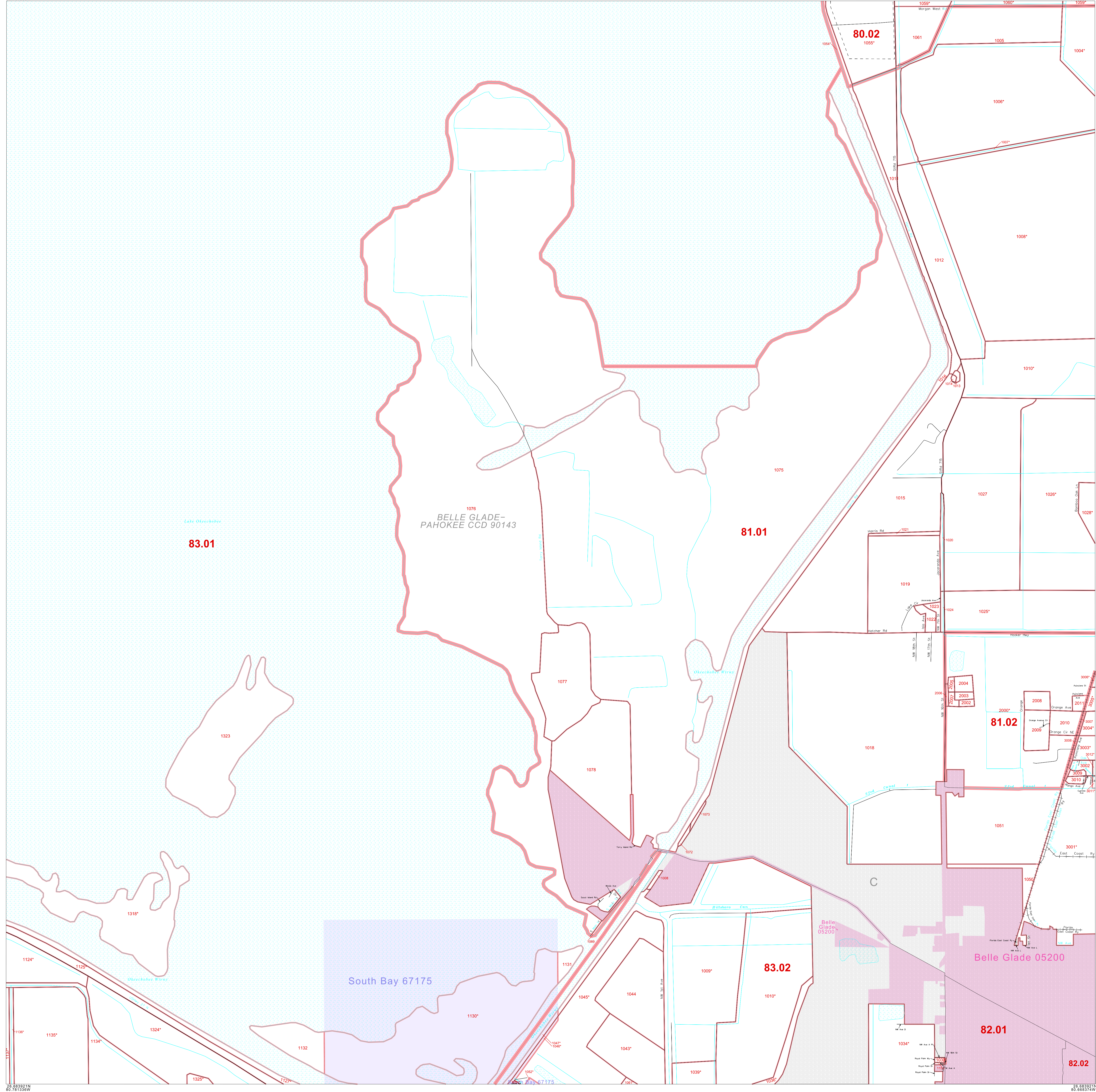


CENSUS 2000 BLOCK MAP: BELLE GLADE-PAHOKEE CCD

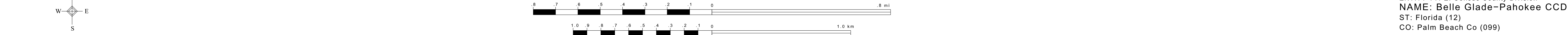
