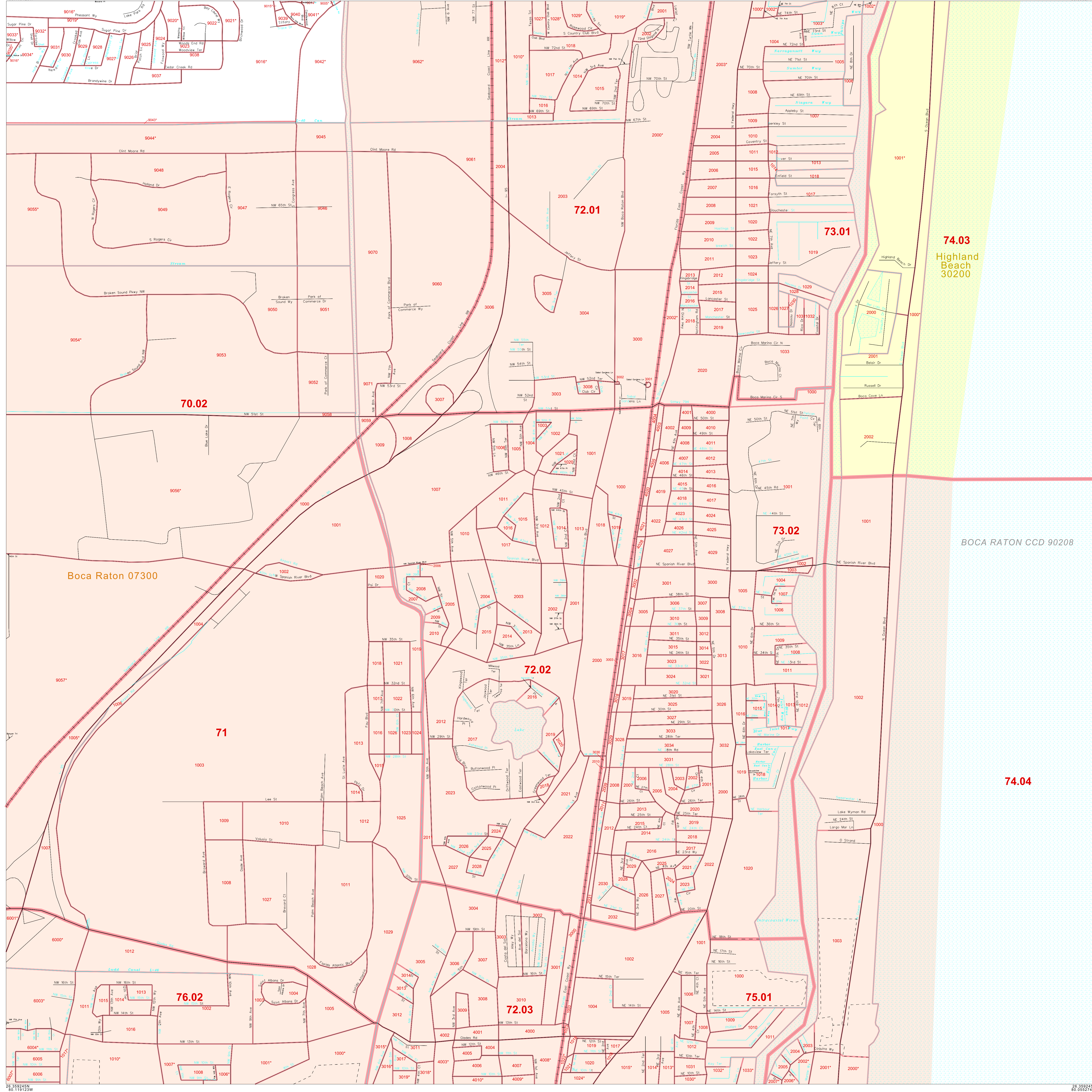


CENSUS 2000 BLOCK MAP: BOCA RATON CCD
