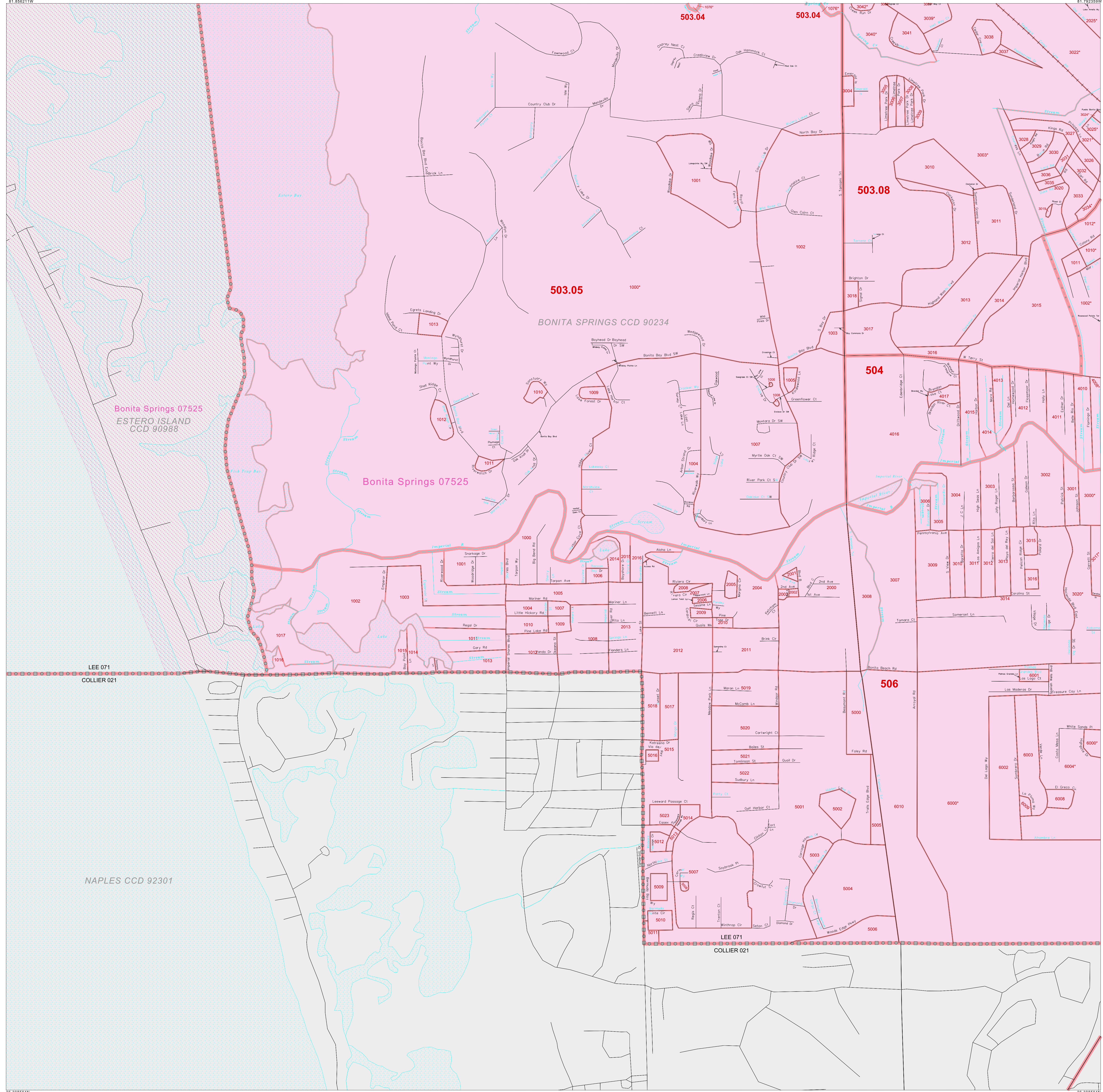


CENSUS 2000 BLOCK MAP: BONITA SPRINGS CCD
