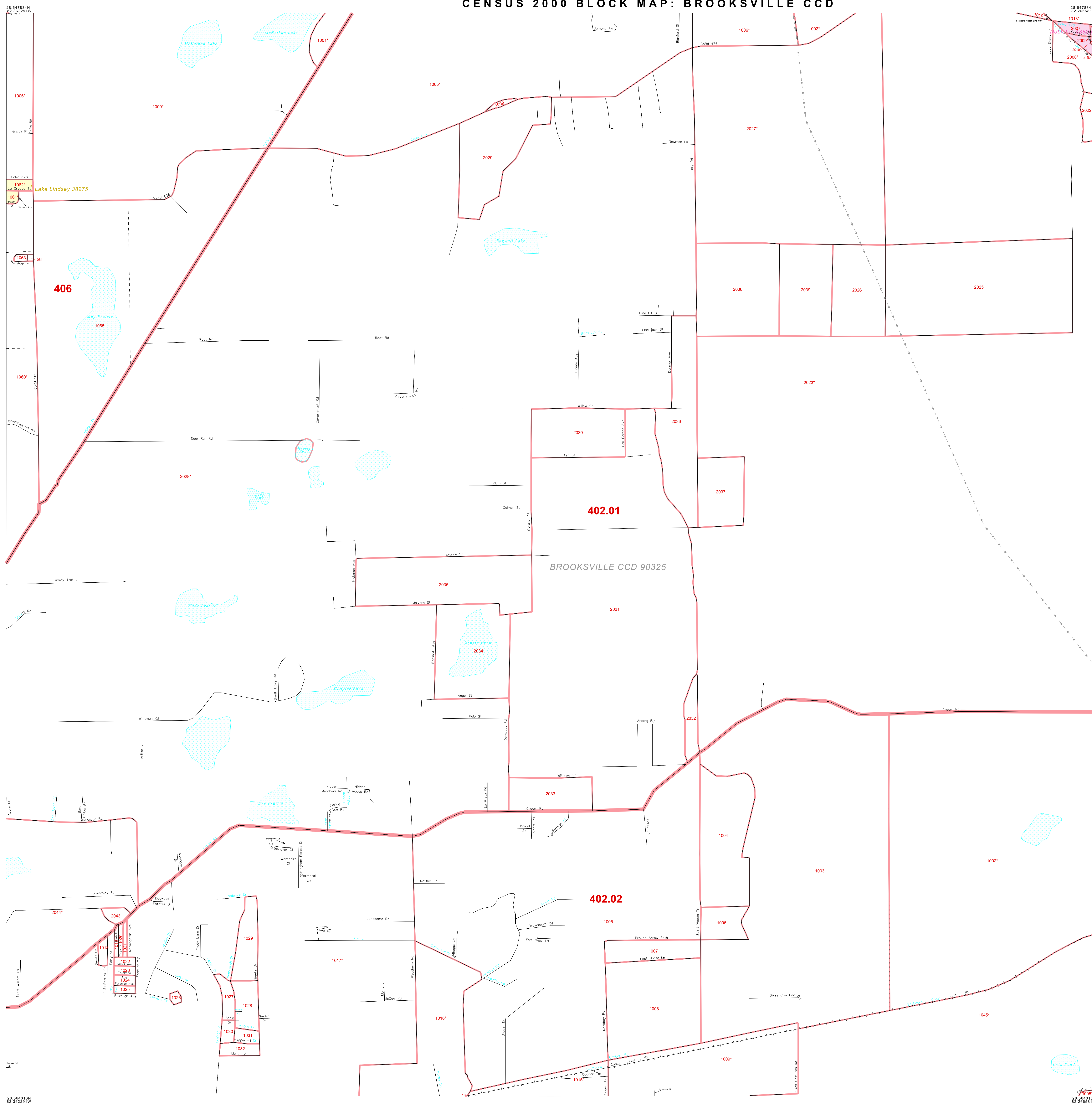


CENSUS 2000 BLOCK MAP: BROOKSVILLE CCD
