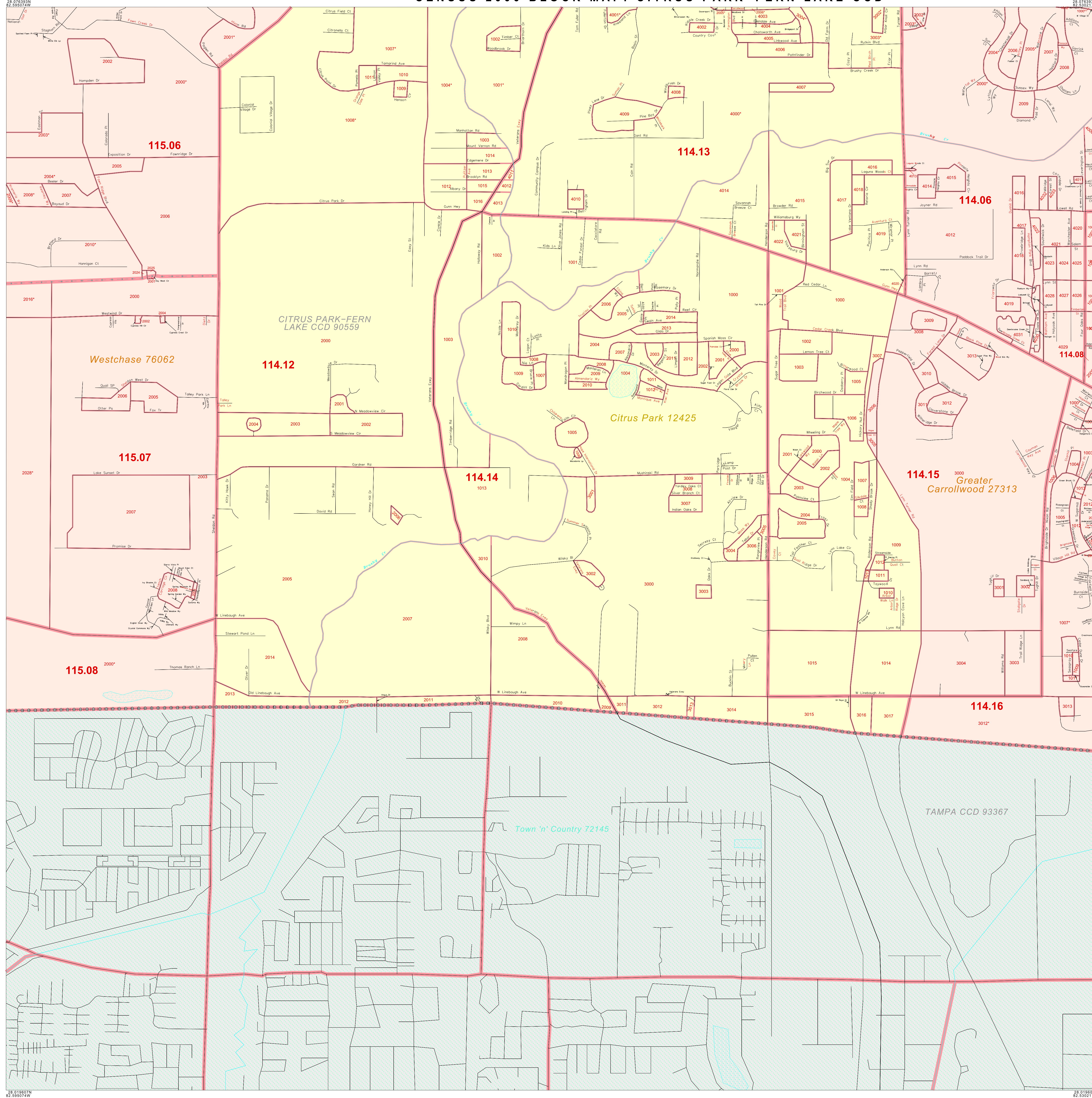


CENSUS 2000 BLOCK MAP: CITRUS PARK-FERN LAKE CCD
