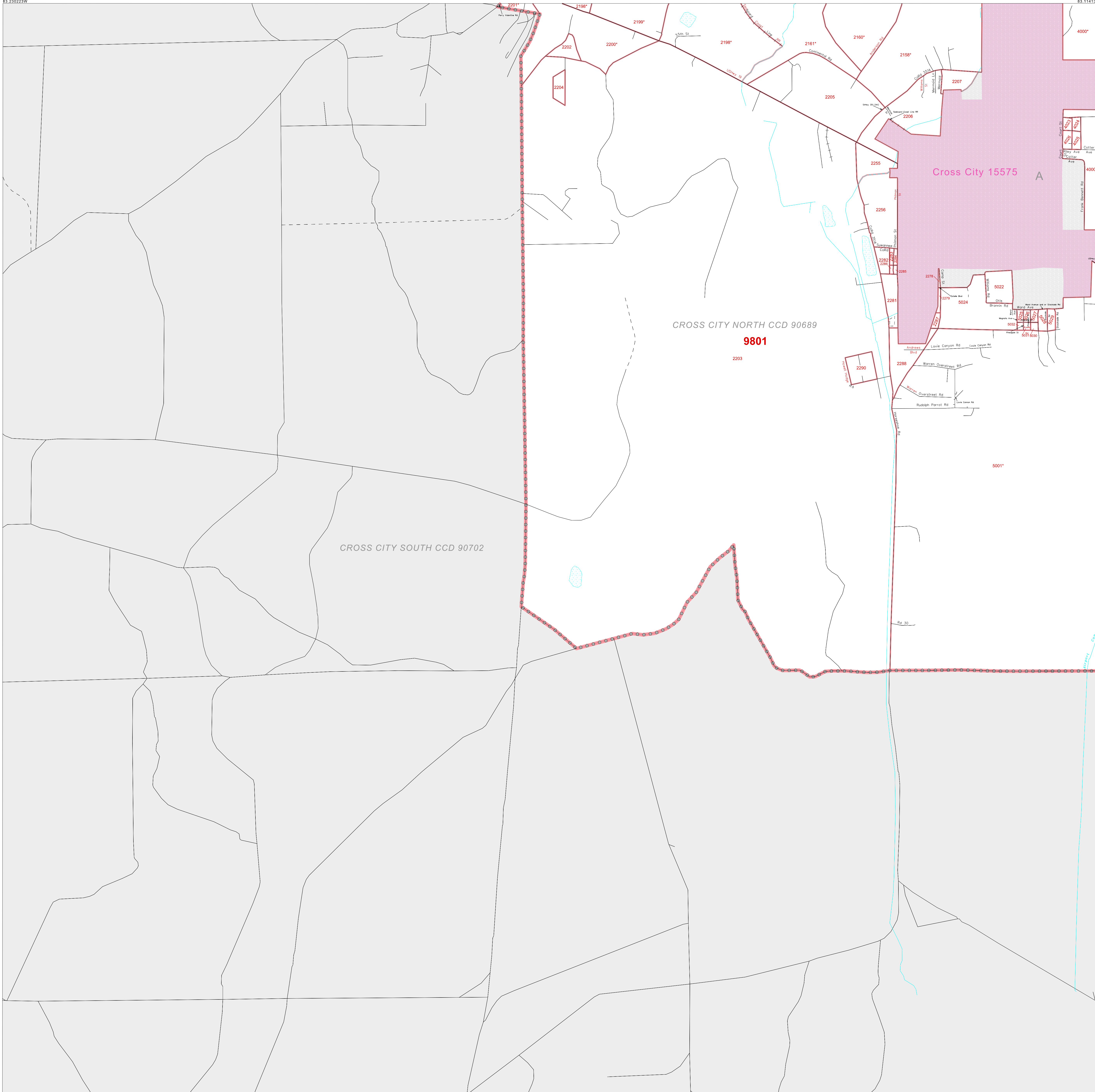


CENSUS 2000 BLOCK MAP: CROSS CITY NORTH CCD

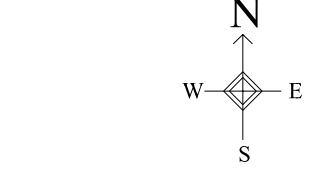
