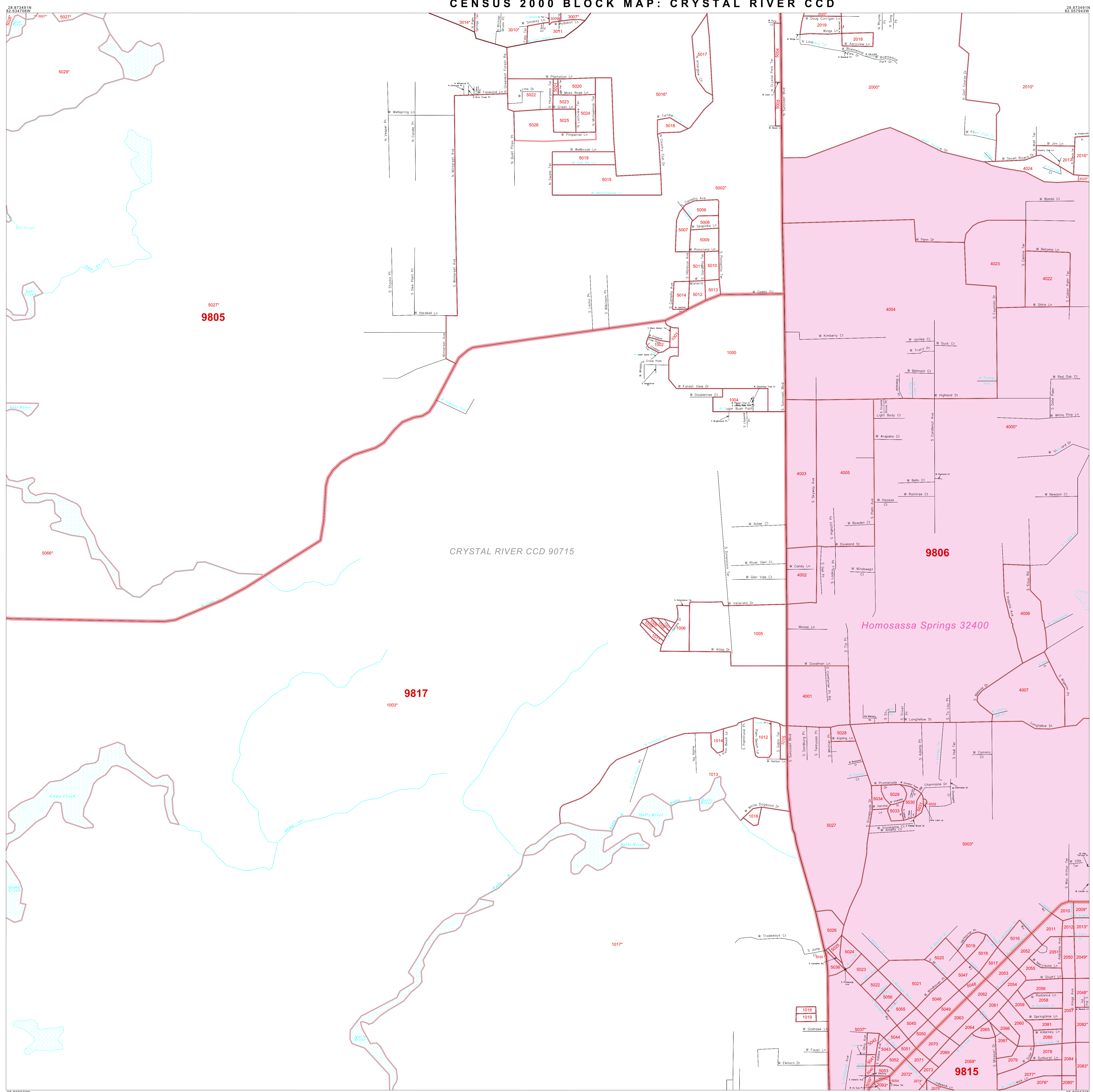


CENSUS 2000 BLOCK MAP: CRYSTAL RIVER CCD

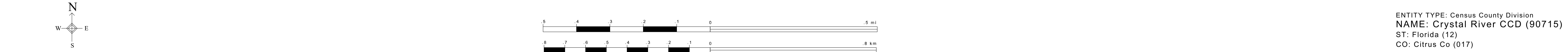
