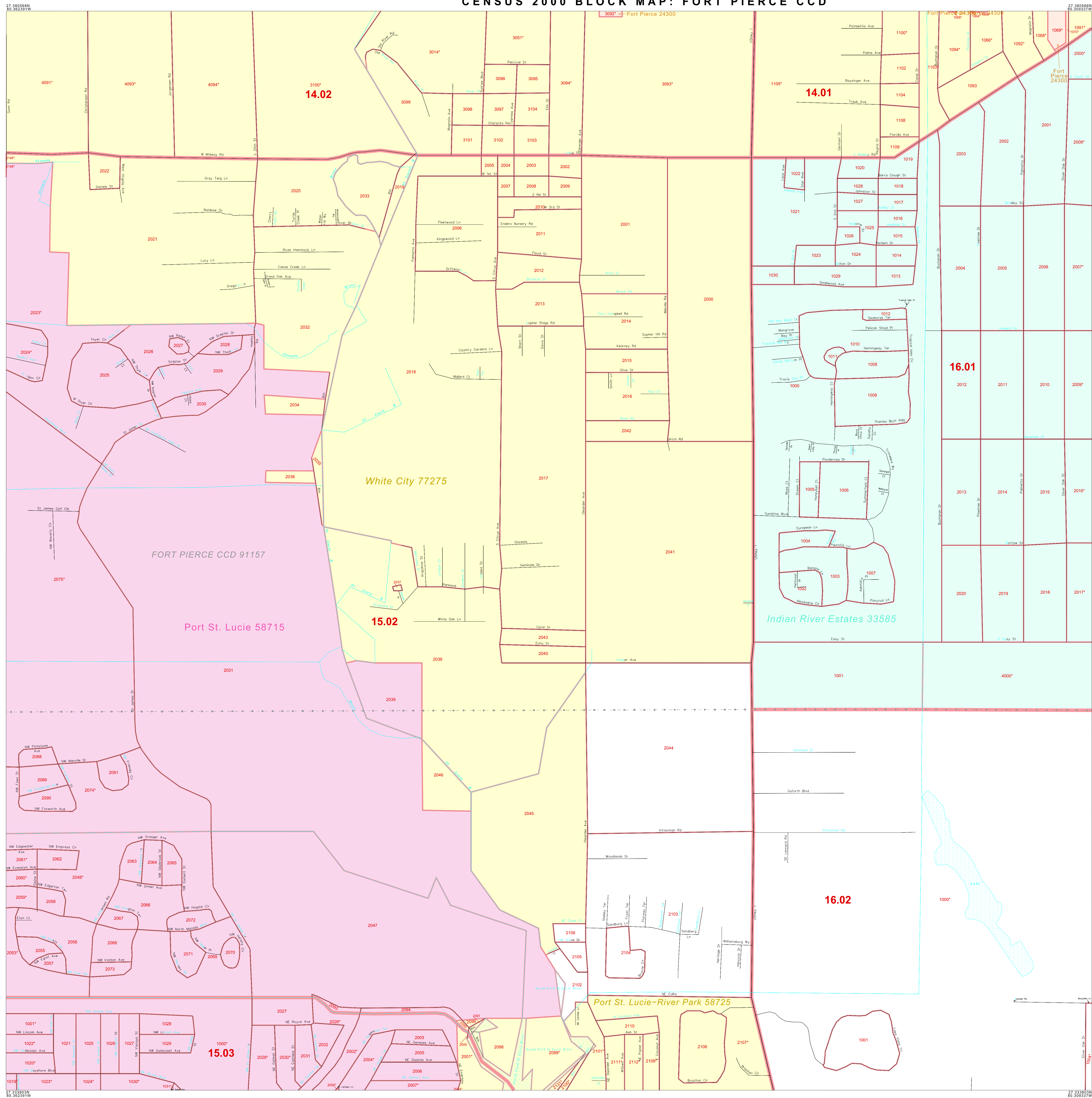


CENSUS 2000 BLOCK MAP: FORT PIERCE CCD

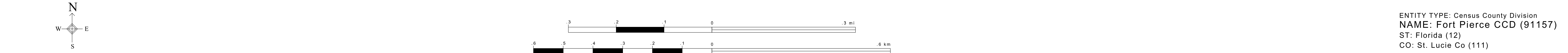
