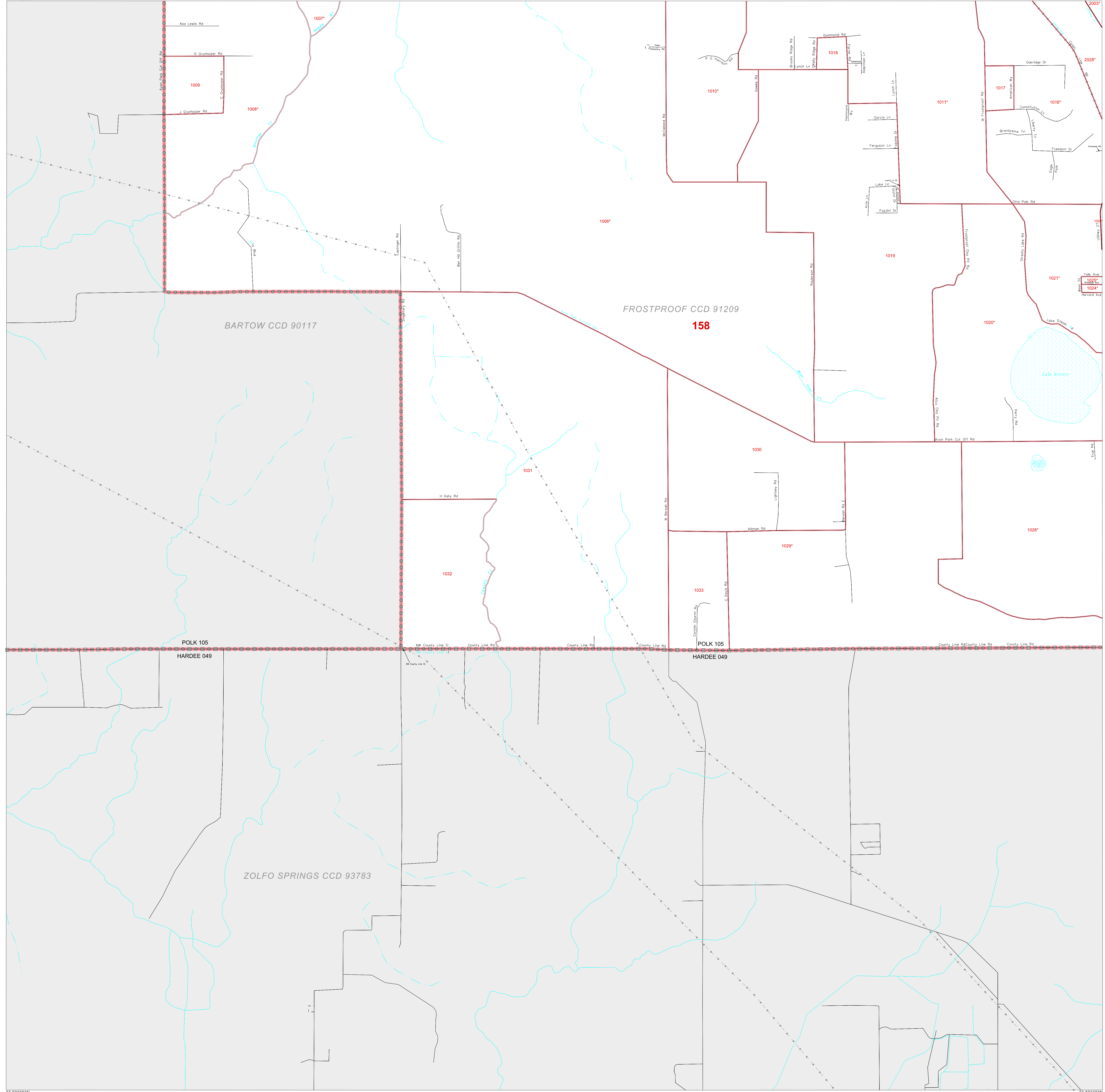


CENSUS 2000 BLOCK MAP: FROSTPROOF CCD

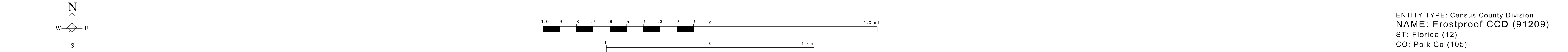
