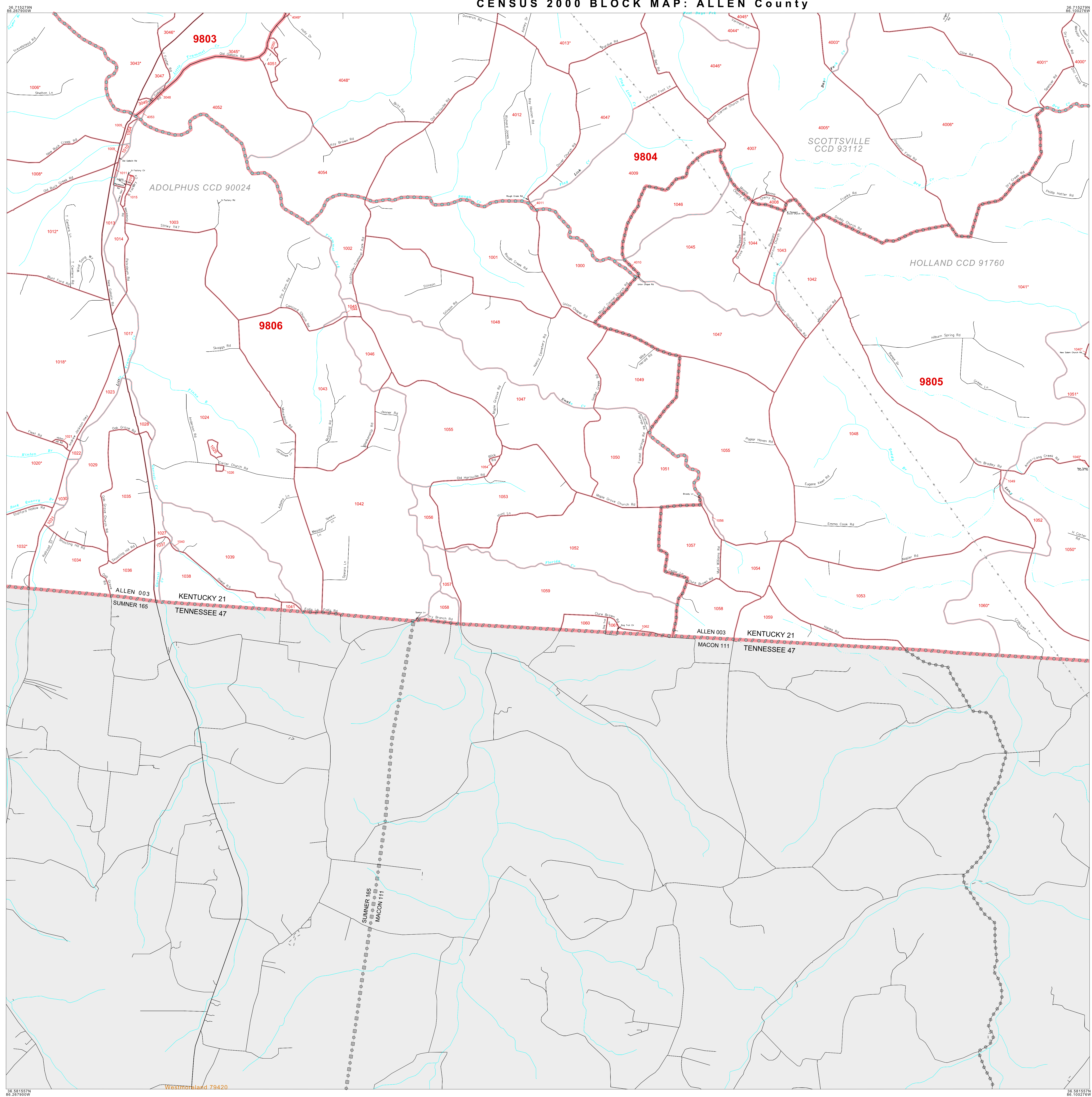


CENSUS 2000 BLOCK MAP: ALLEN County
