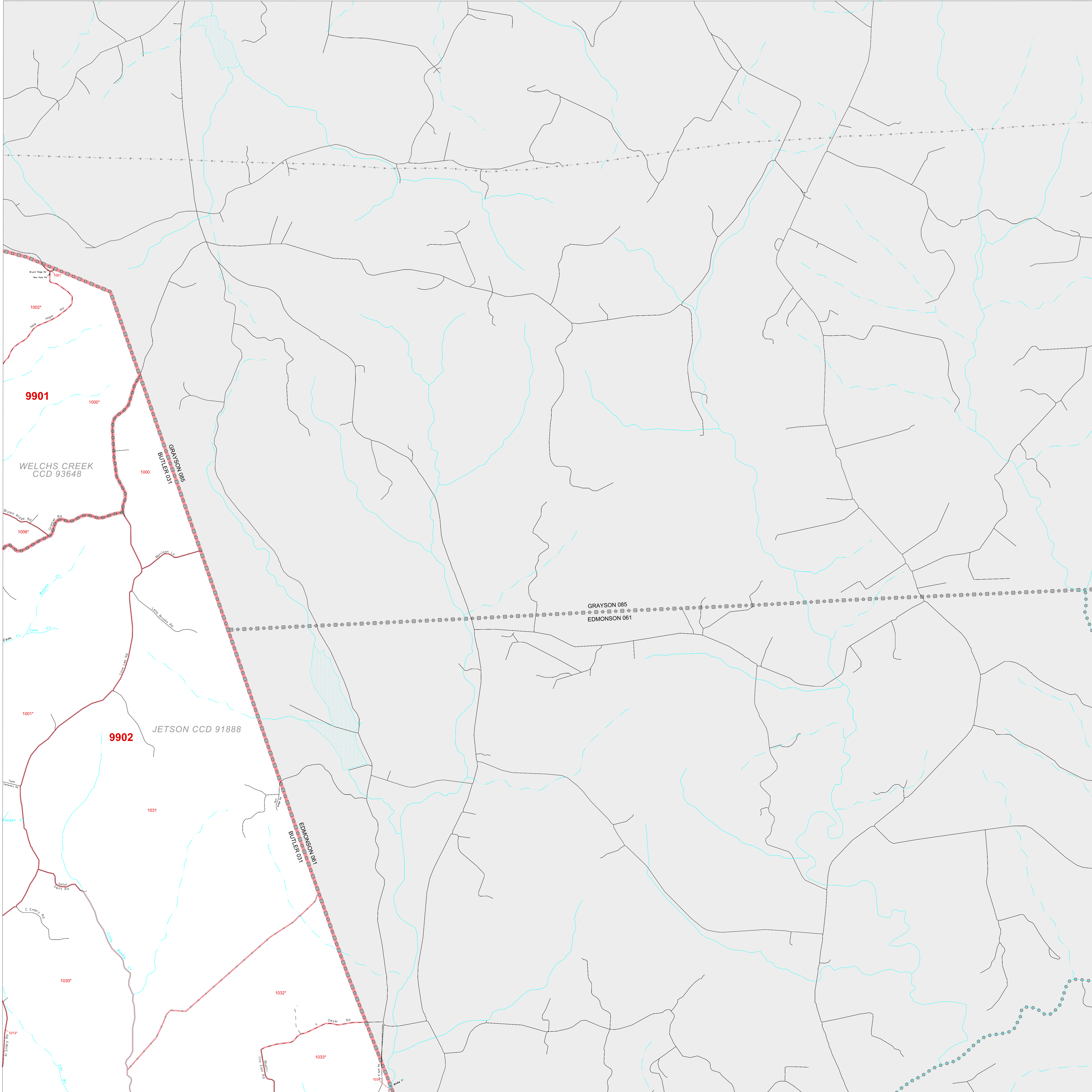


CENSUS 2000 BLOCK MAP: BUTLER County

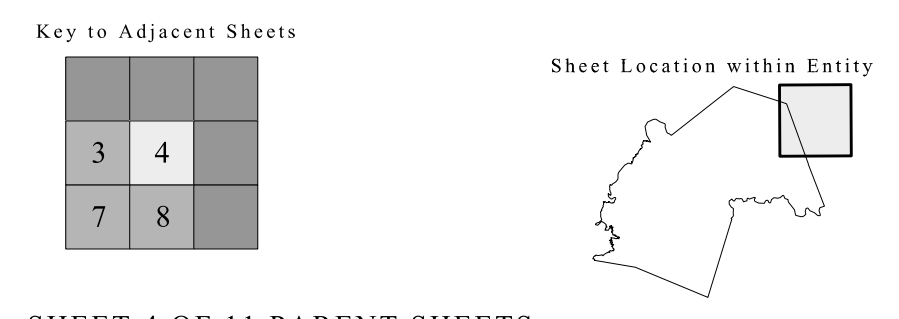
