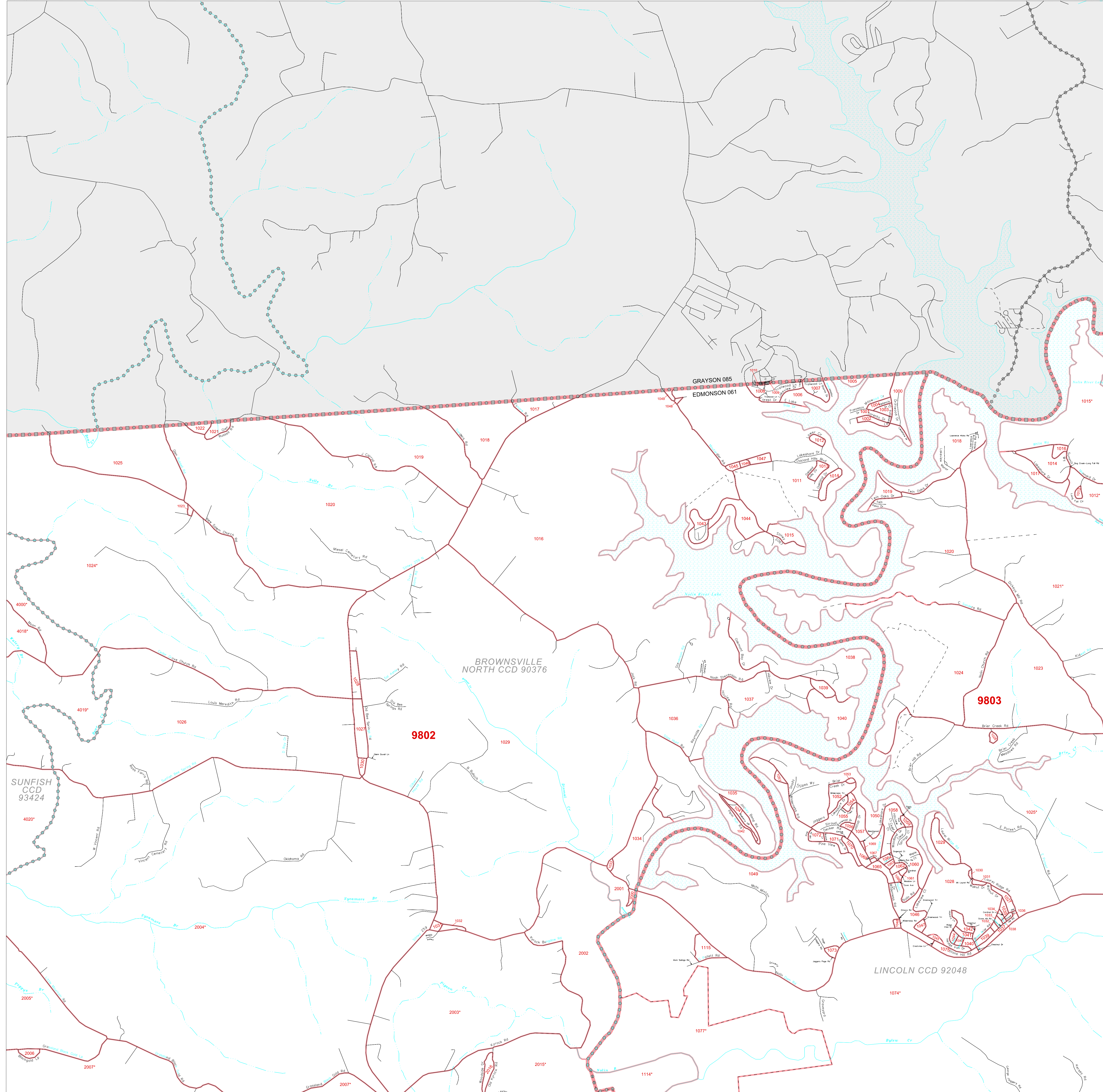


CENSUS 2000 BLOCK MAP: EDMONSON County

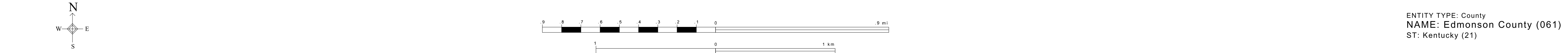
