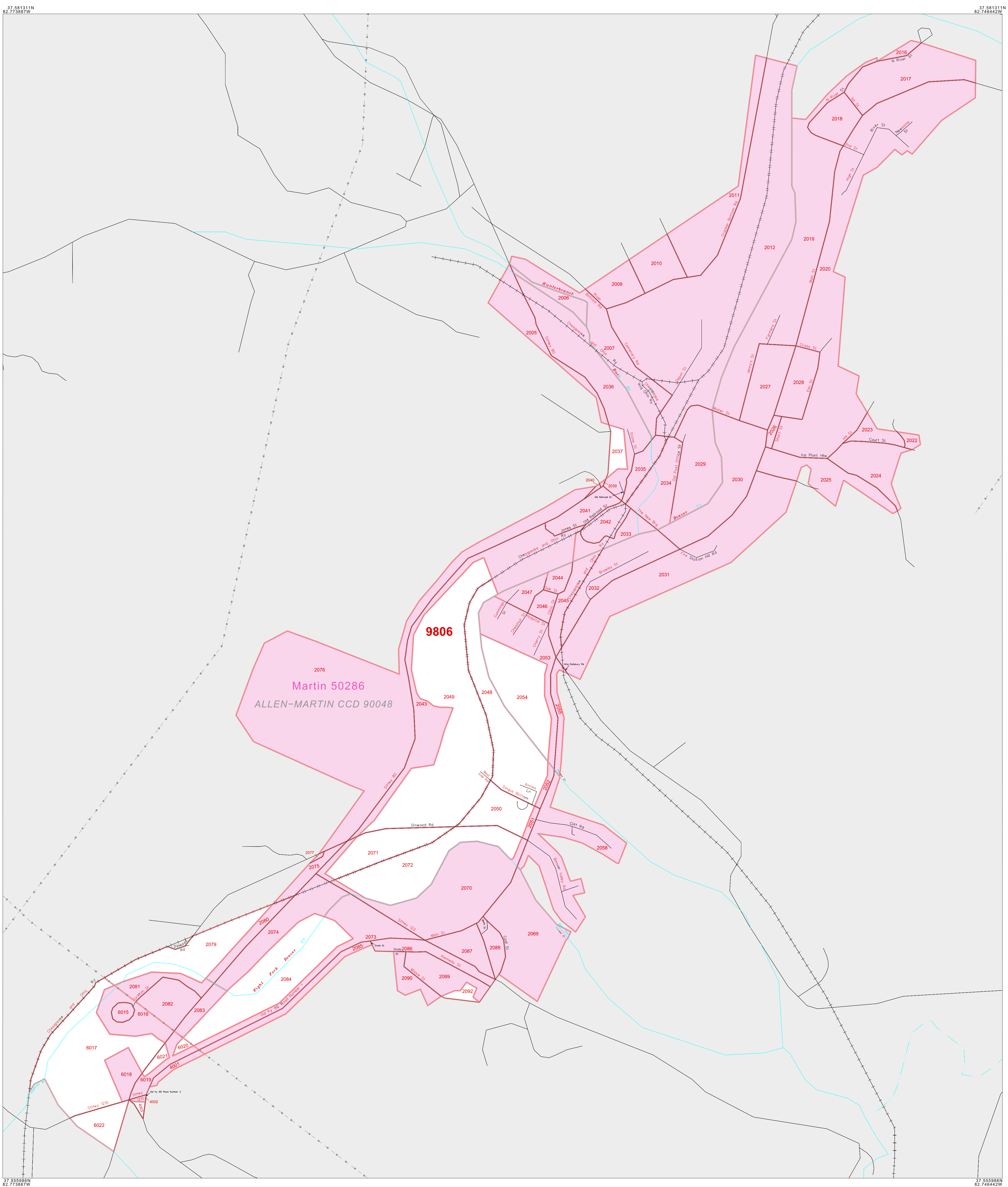


CENSUS 2000 BLOCK MAP: FLOYD County
