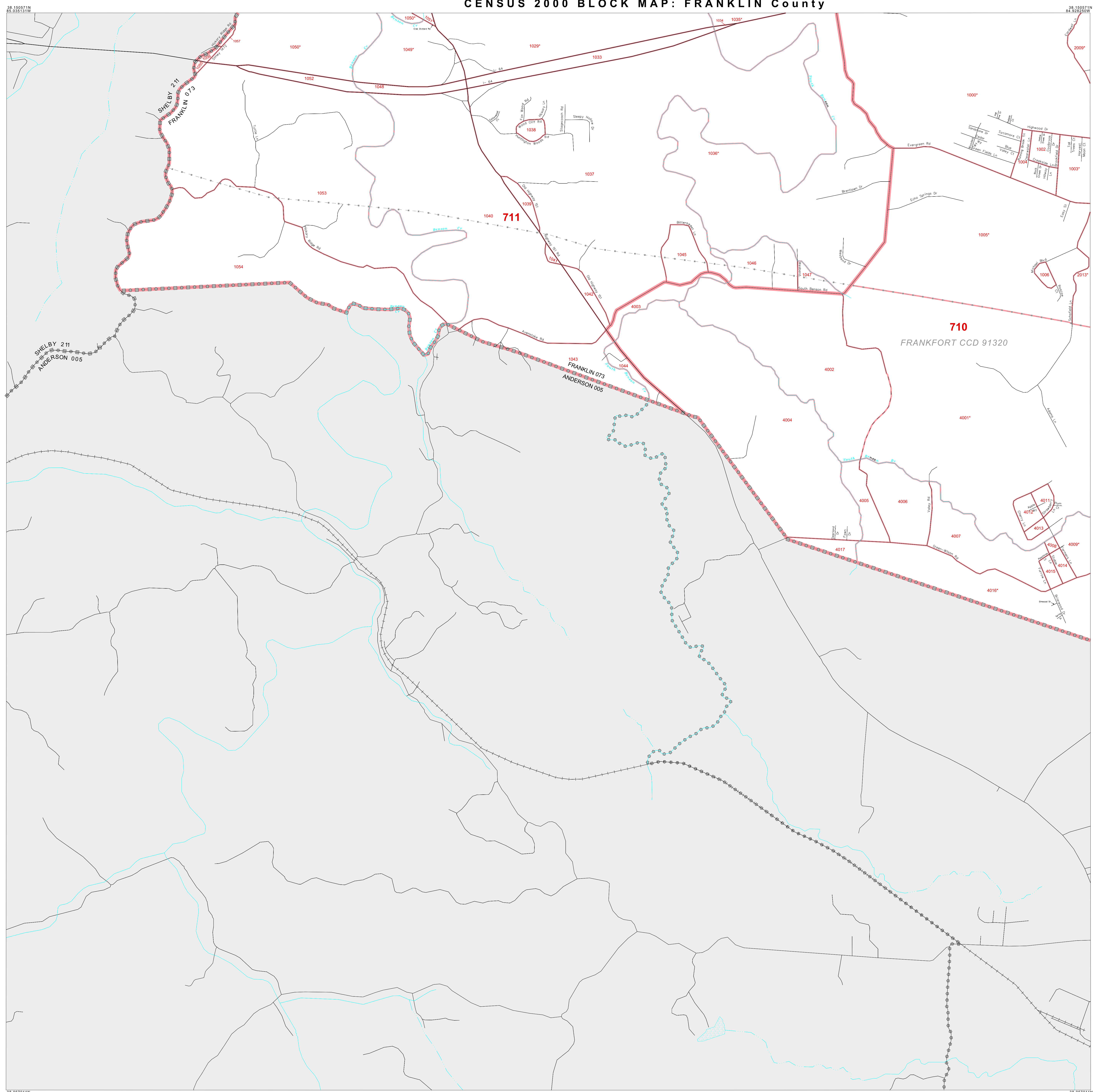


CENSUS 2000 BLOCK MAP: FRANKLIN County

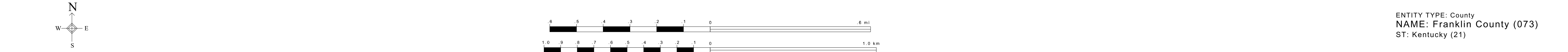
