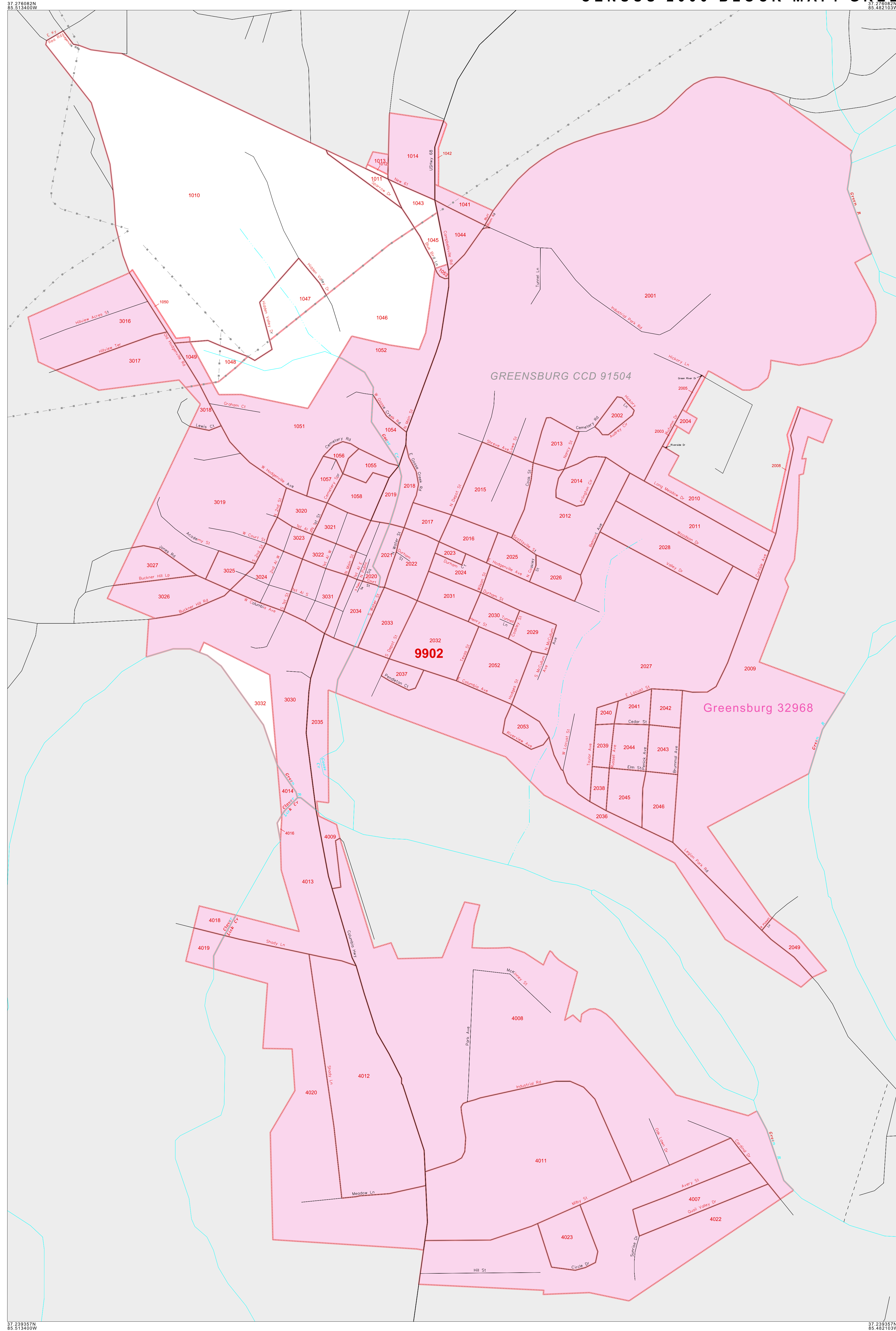


CENSUS 2000 BLOCK MAP: GREEN County
