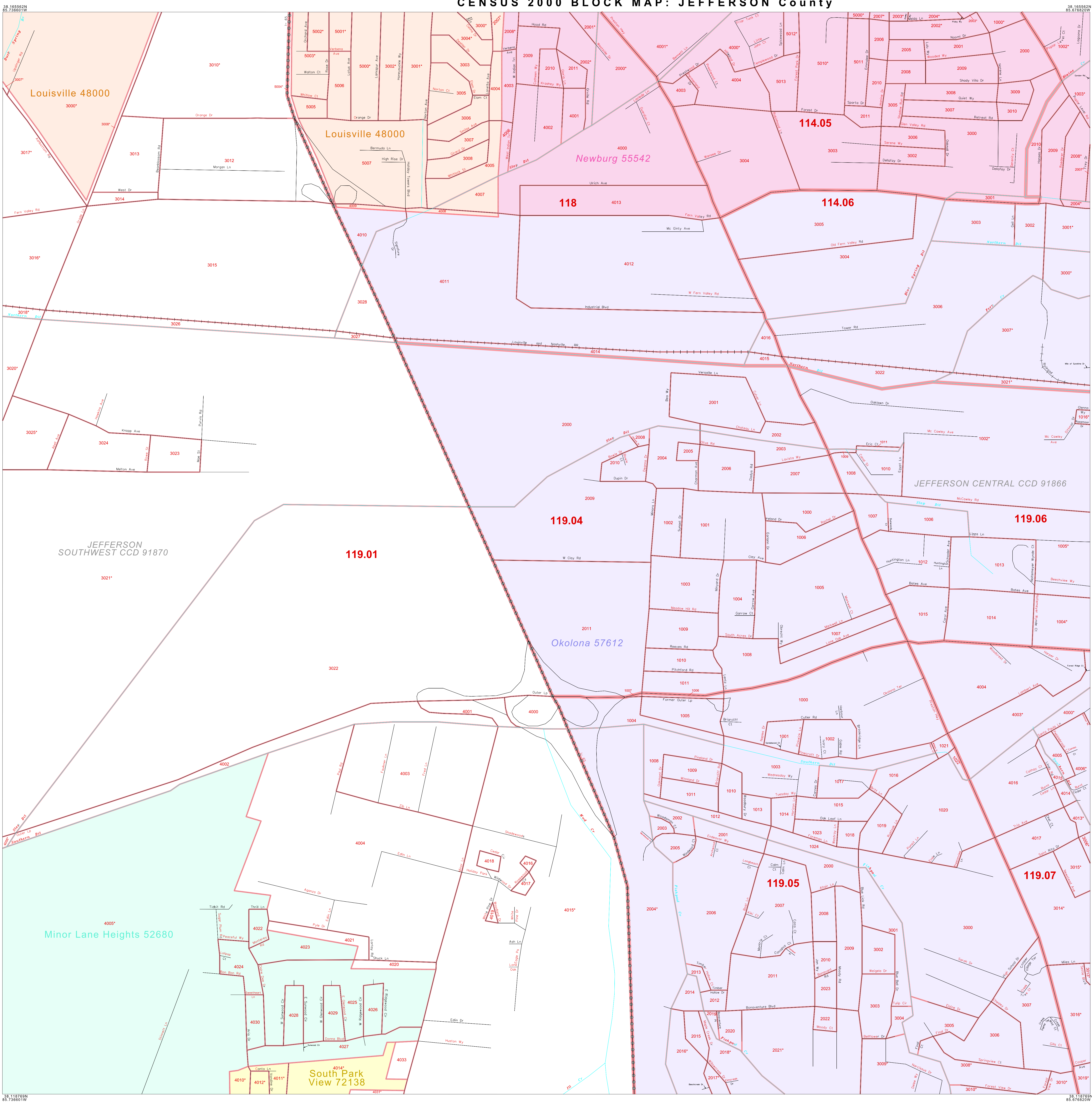


CENSUS 2000 BLOCK MAP: JEFFERSON County

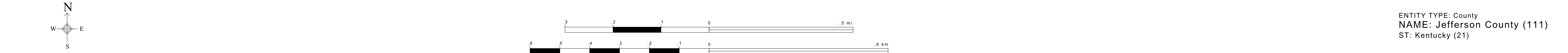
