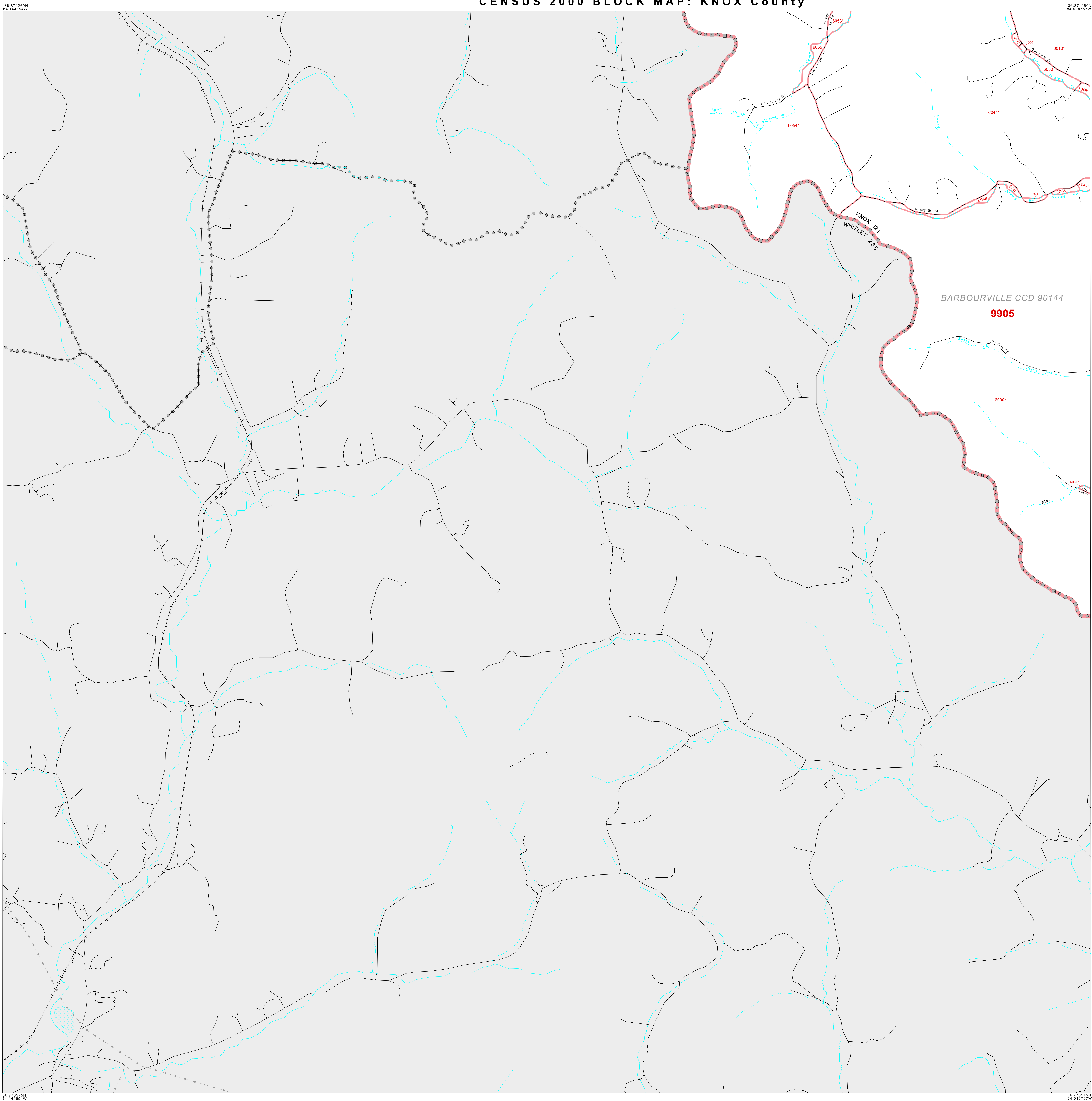


CENSUS 2000 BLOCK MAP: KNOX County
