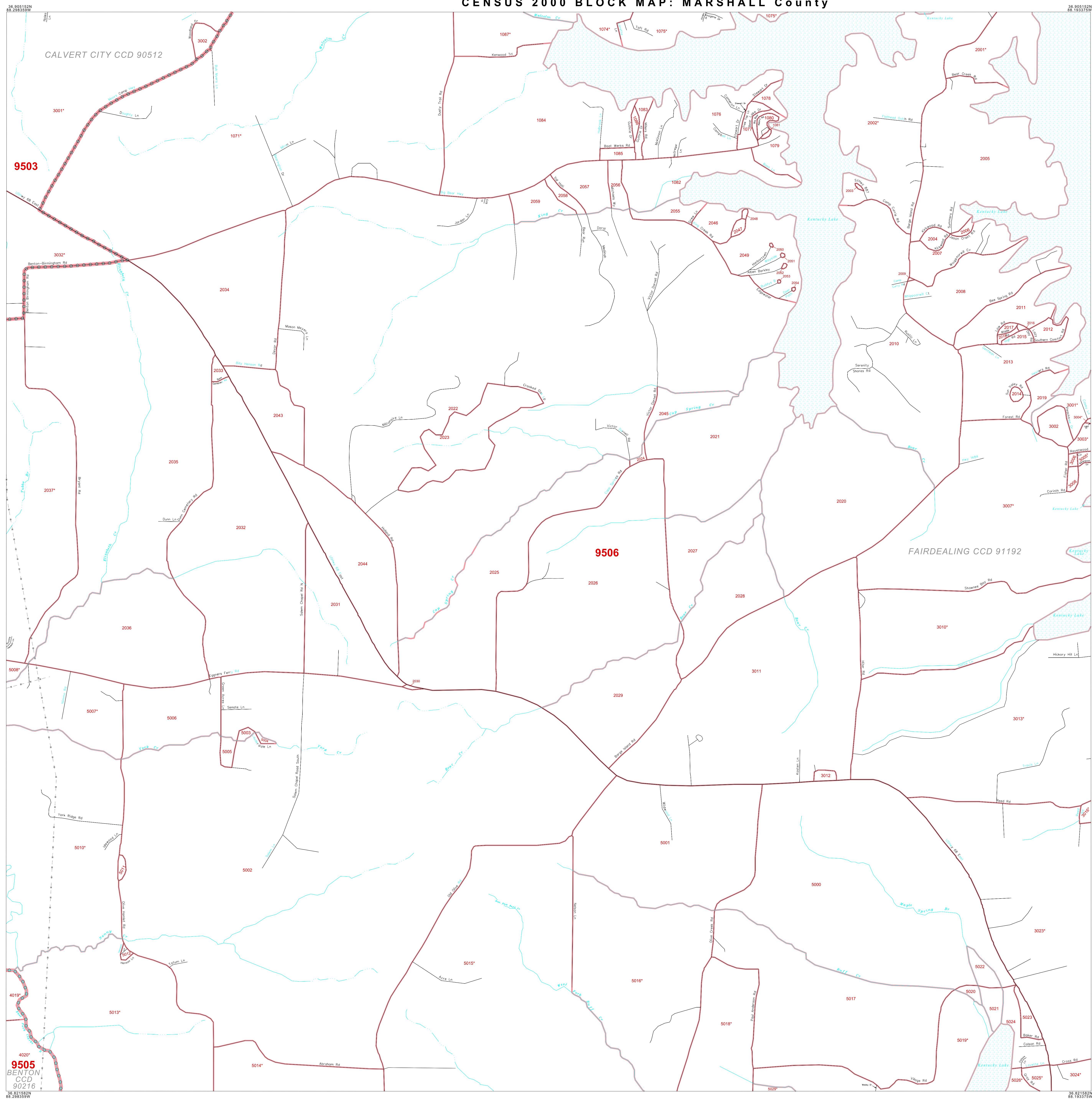


CENSUS 2000 BLOCK MAP: MARSHALL County
