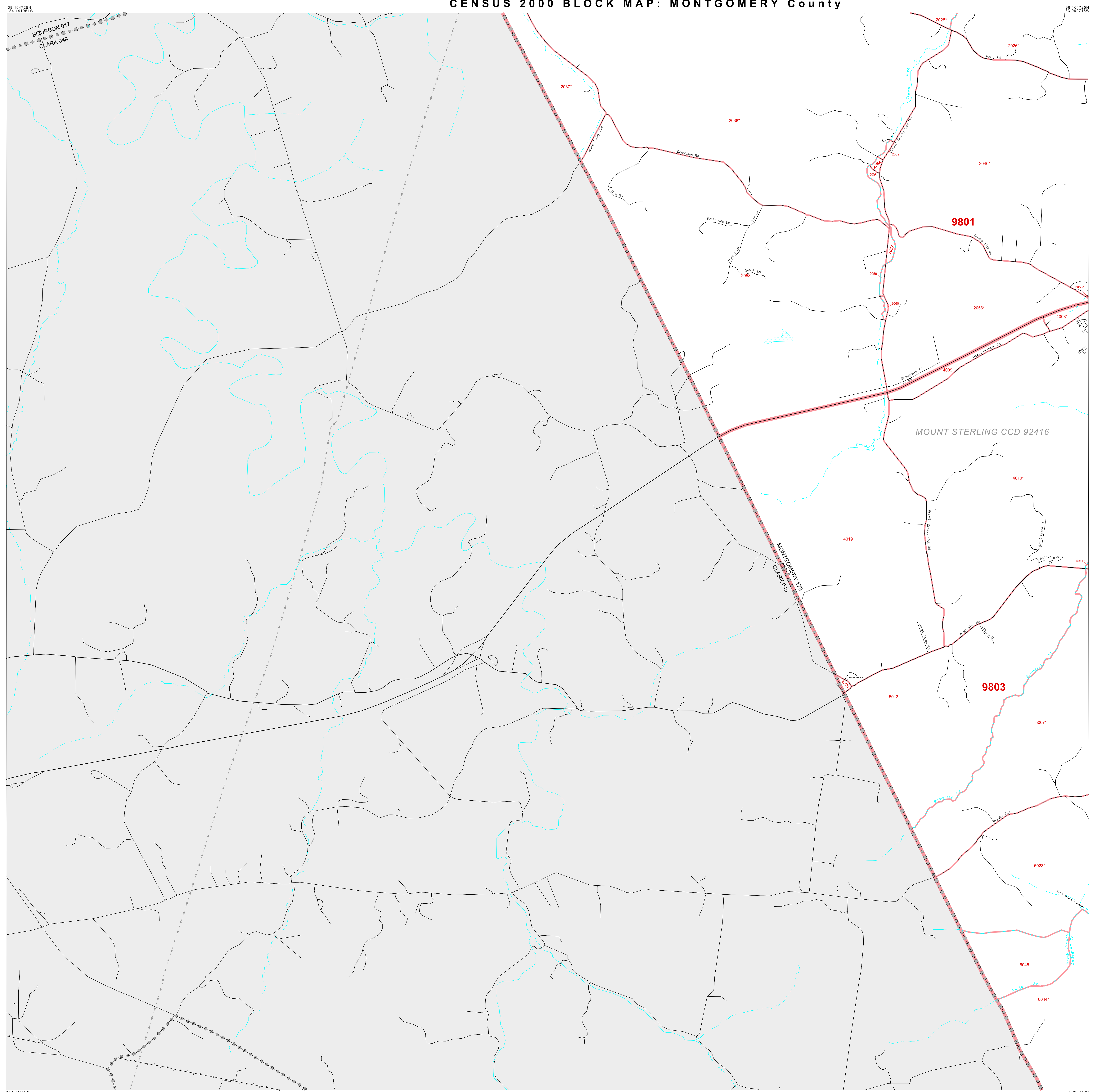


CENSUS 2000 BLOCK MAP: MONTGOMERY County
