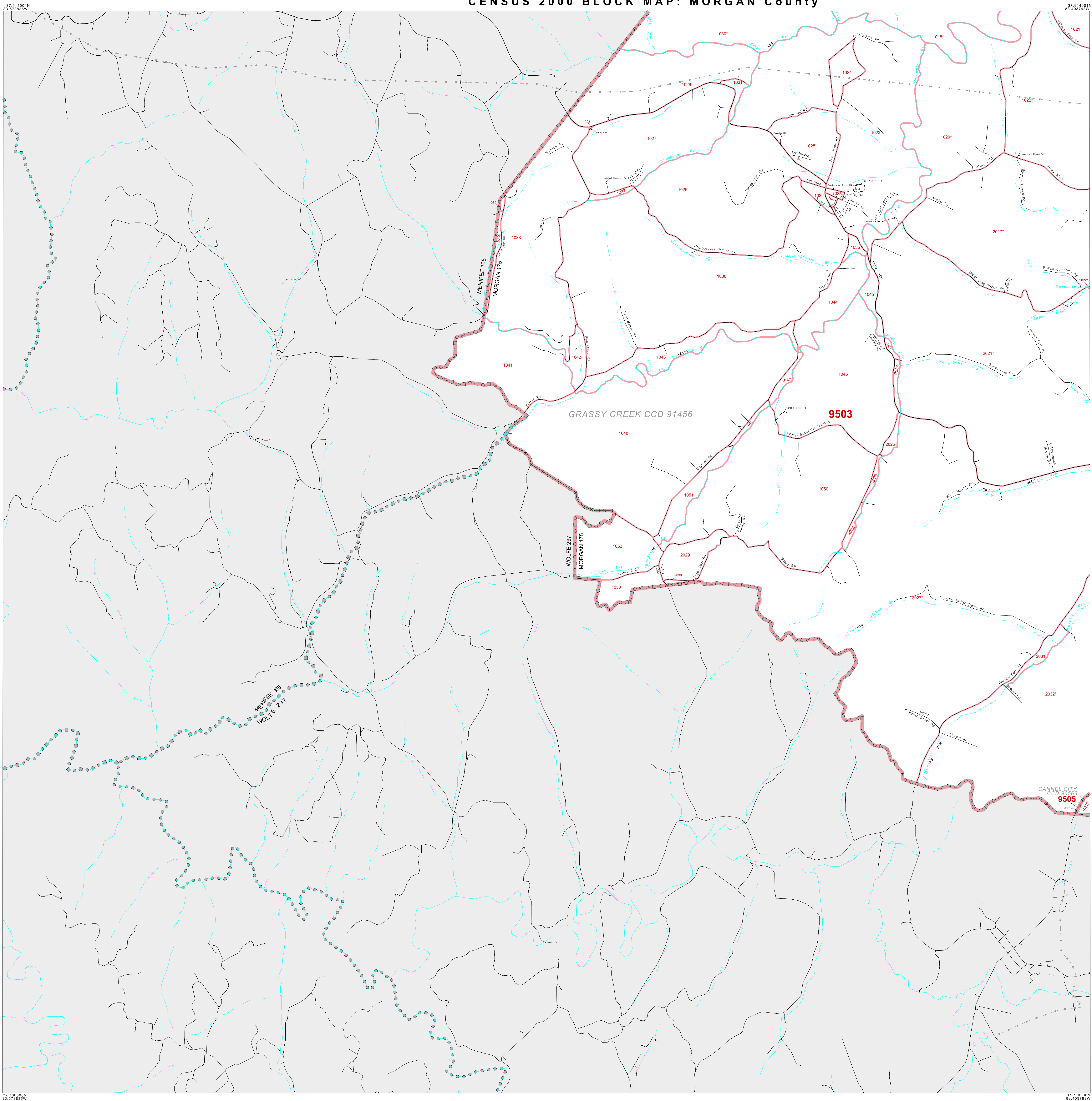


CENSUS 2000 BLOCK MAP: MORGAN County
