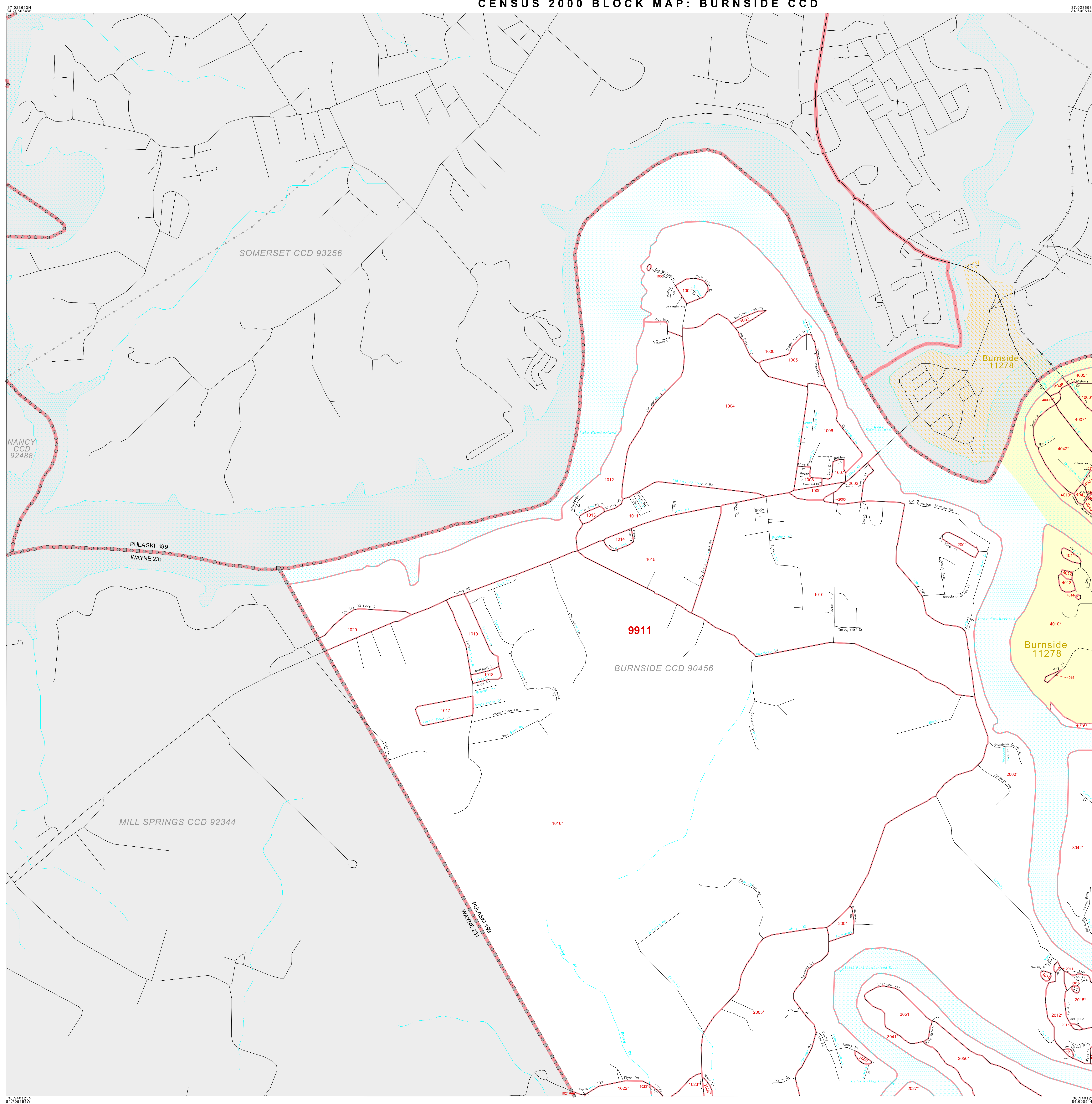


CENSUS 2000 BLOCK MAP: BURNSIDE CCD
