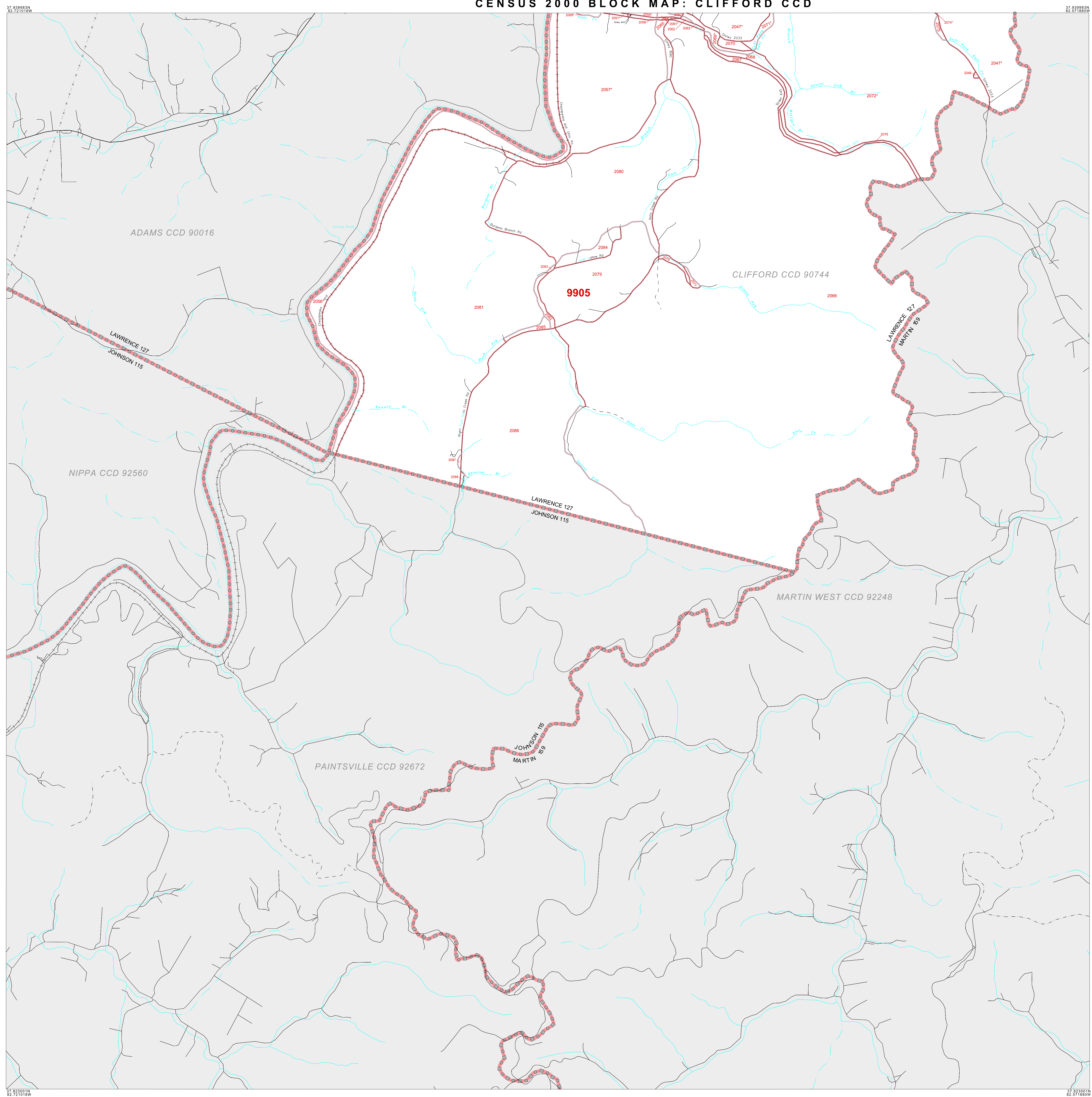


CENSUS 2000 BLOCK MAP: CLIFFORD CCD
