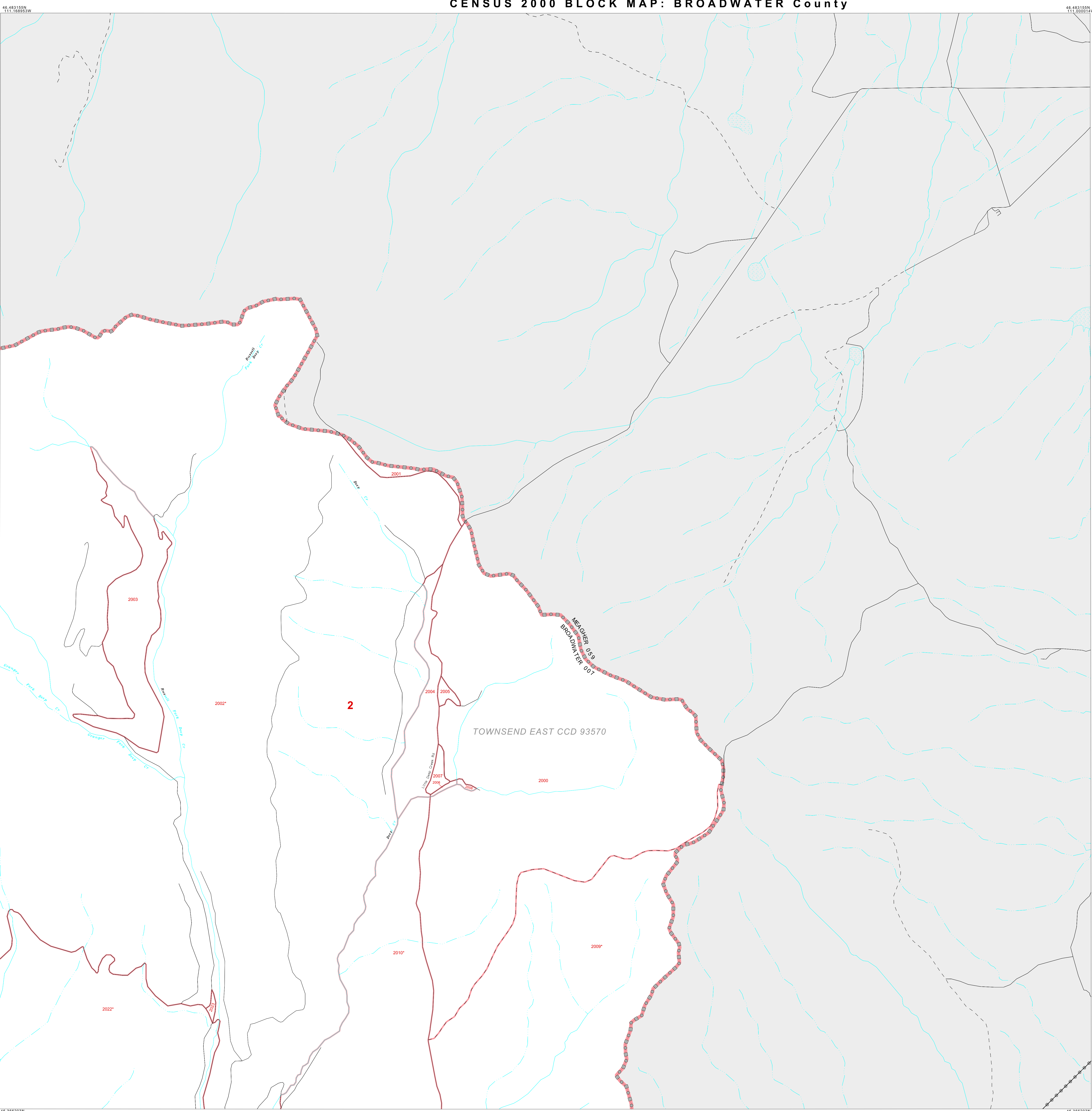


CENSUS 2000 BLOCK MAP: BROADWATER County
