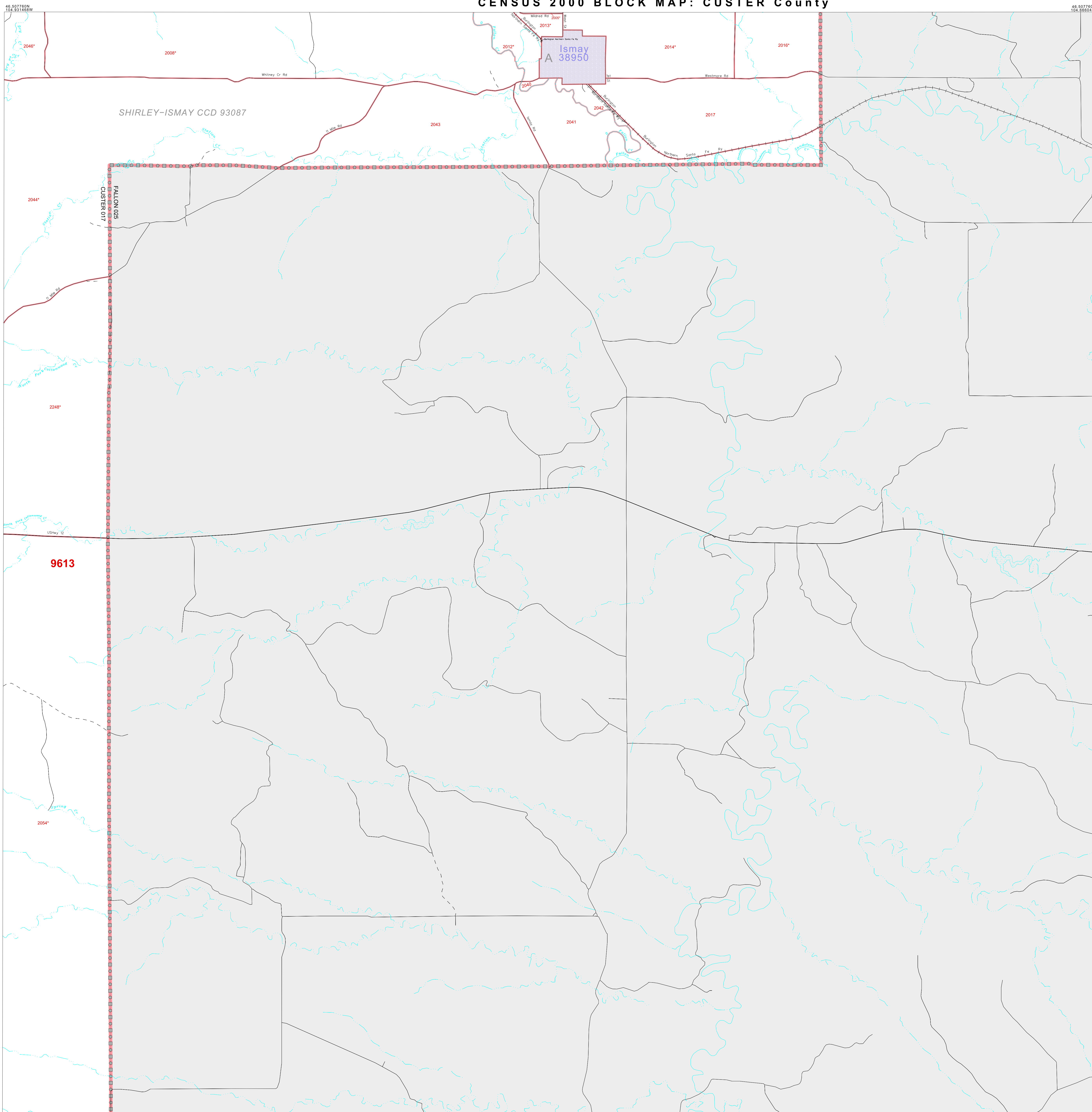


CENSUS 2000 BLOCK MAP: CUSTER County

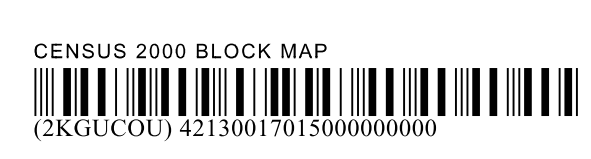
