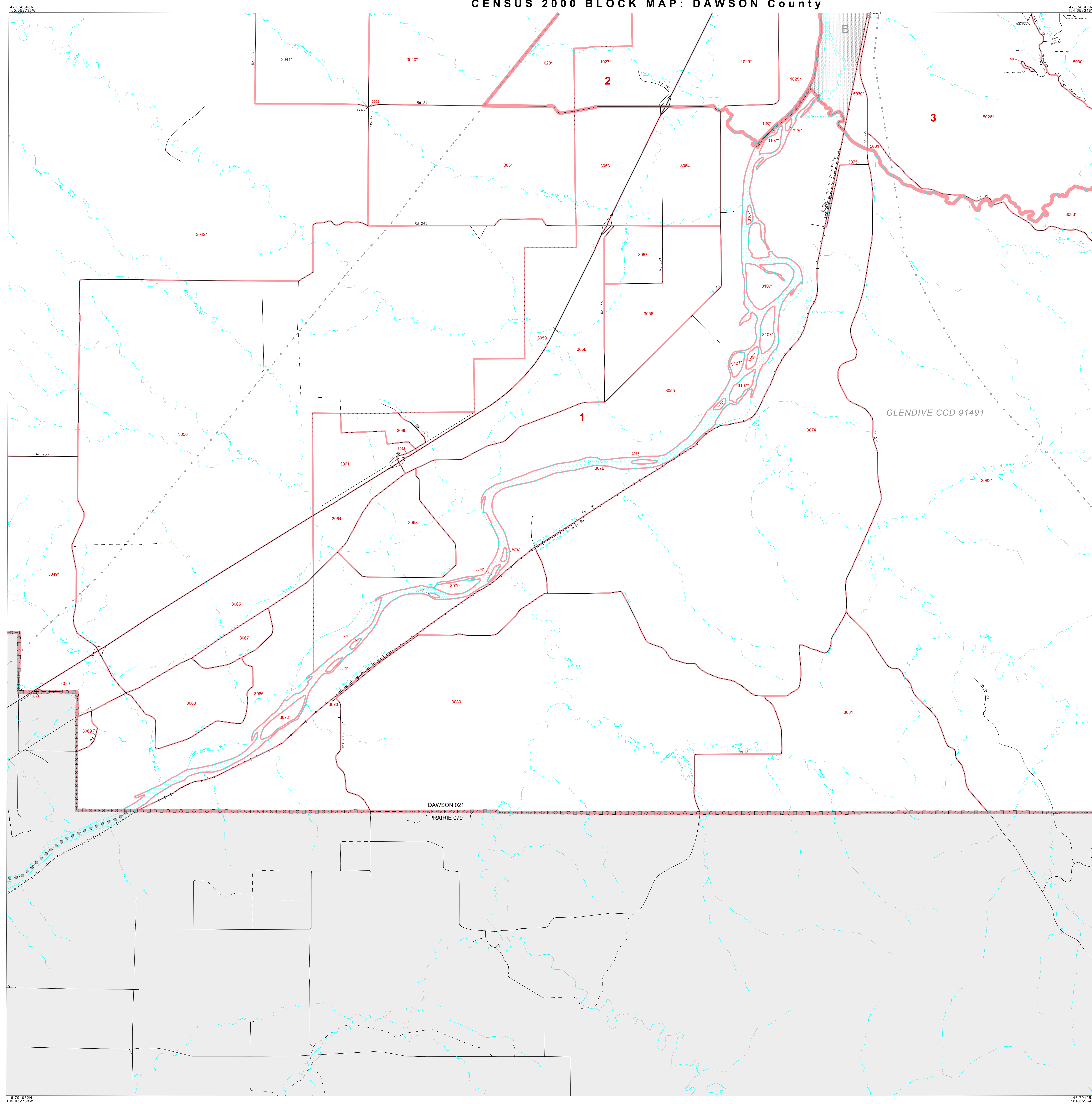


CENSUS 2000 BLOCK MAP: DAWSON County
