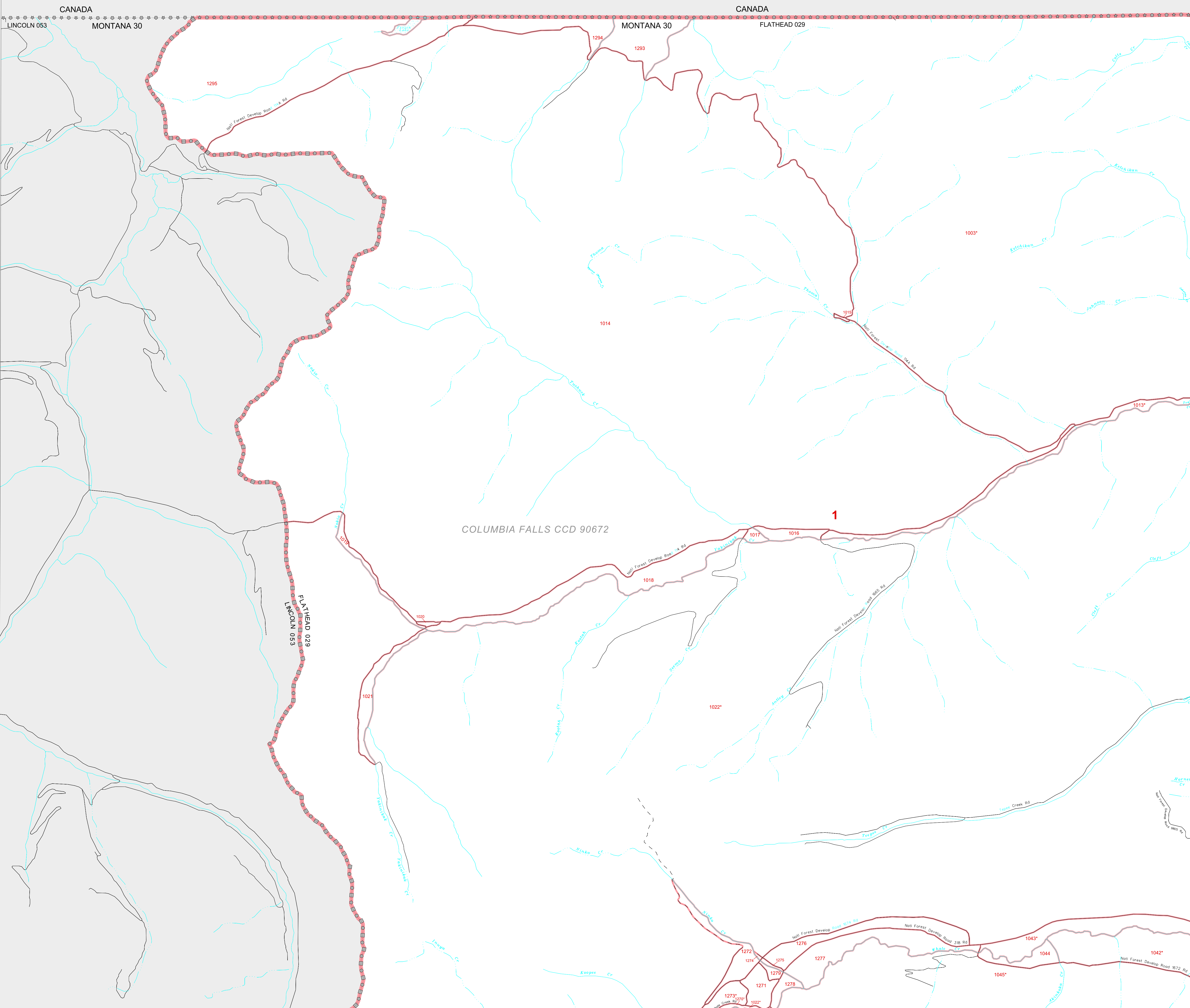


CENSUS 2000 BLOCK MAP: FLATHEAD County
