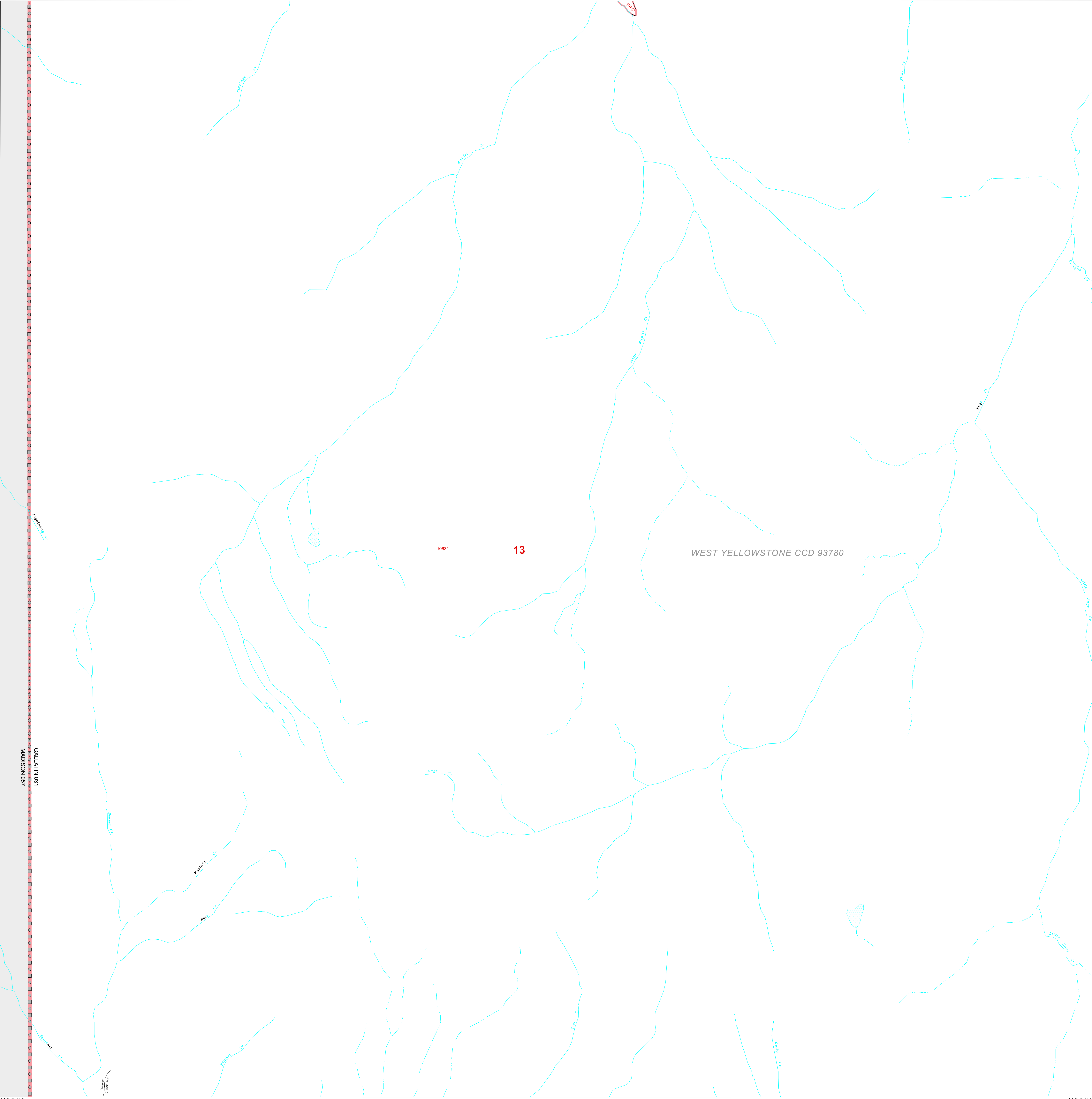


CENSUS 2000 BLOCK MAP: GALLATIN County

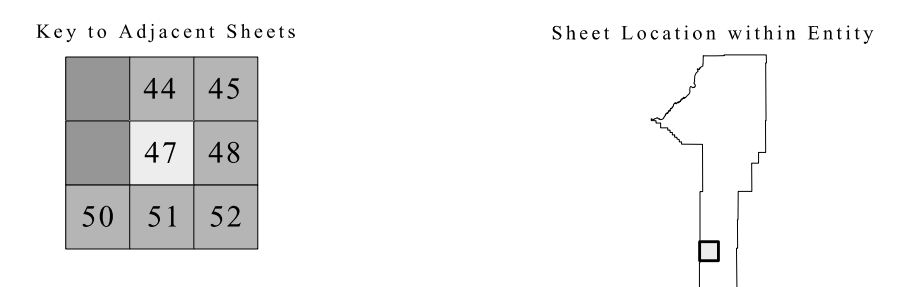
