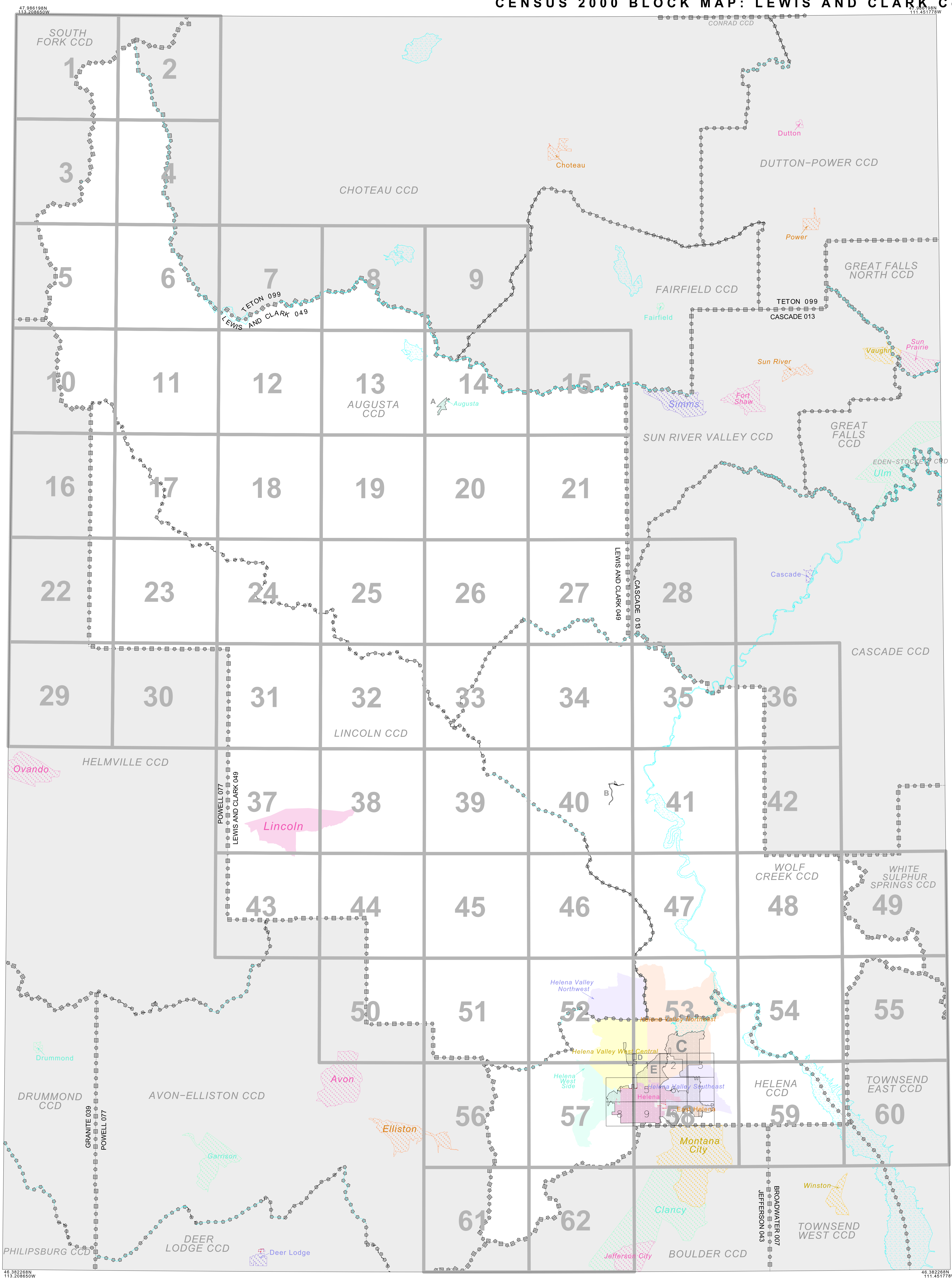


CENSUS 2000 BLOCK MAP: LEWIS AND CLARK County



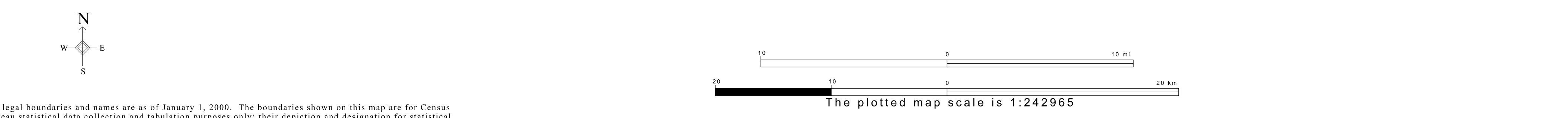
