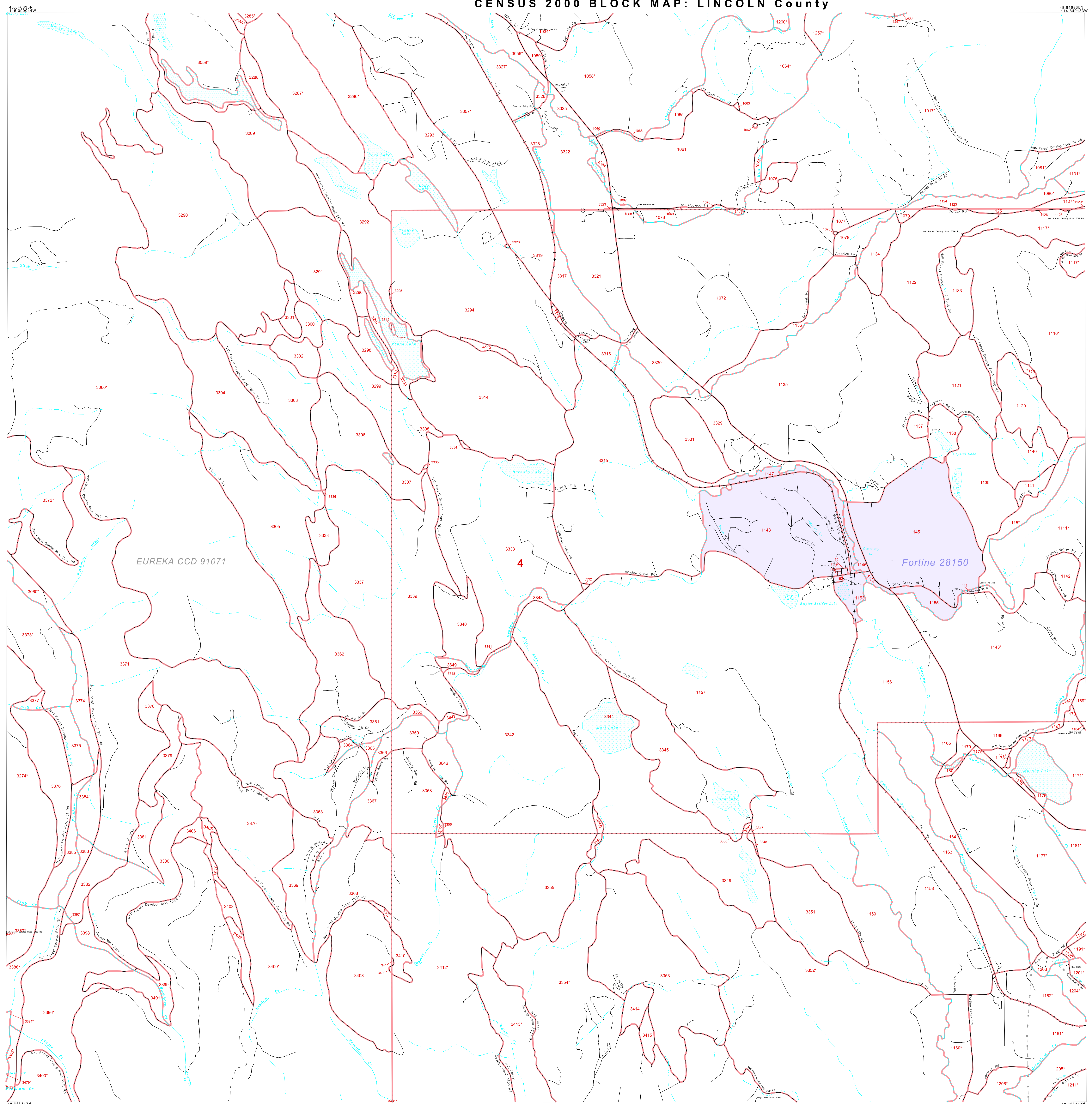


CENSUS 2000 BLOCK MAP: LINCOLN County

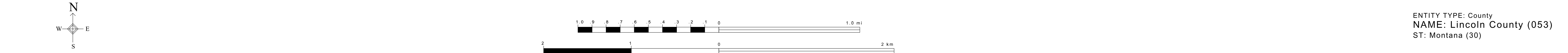
