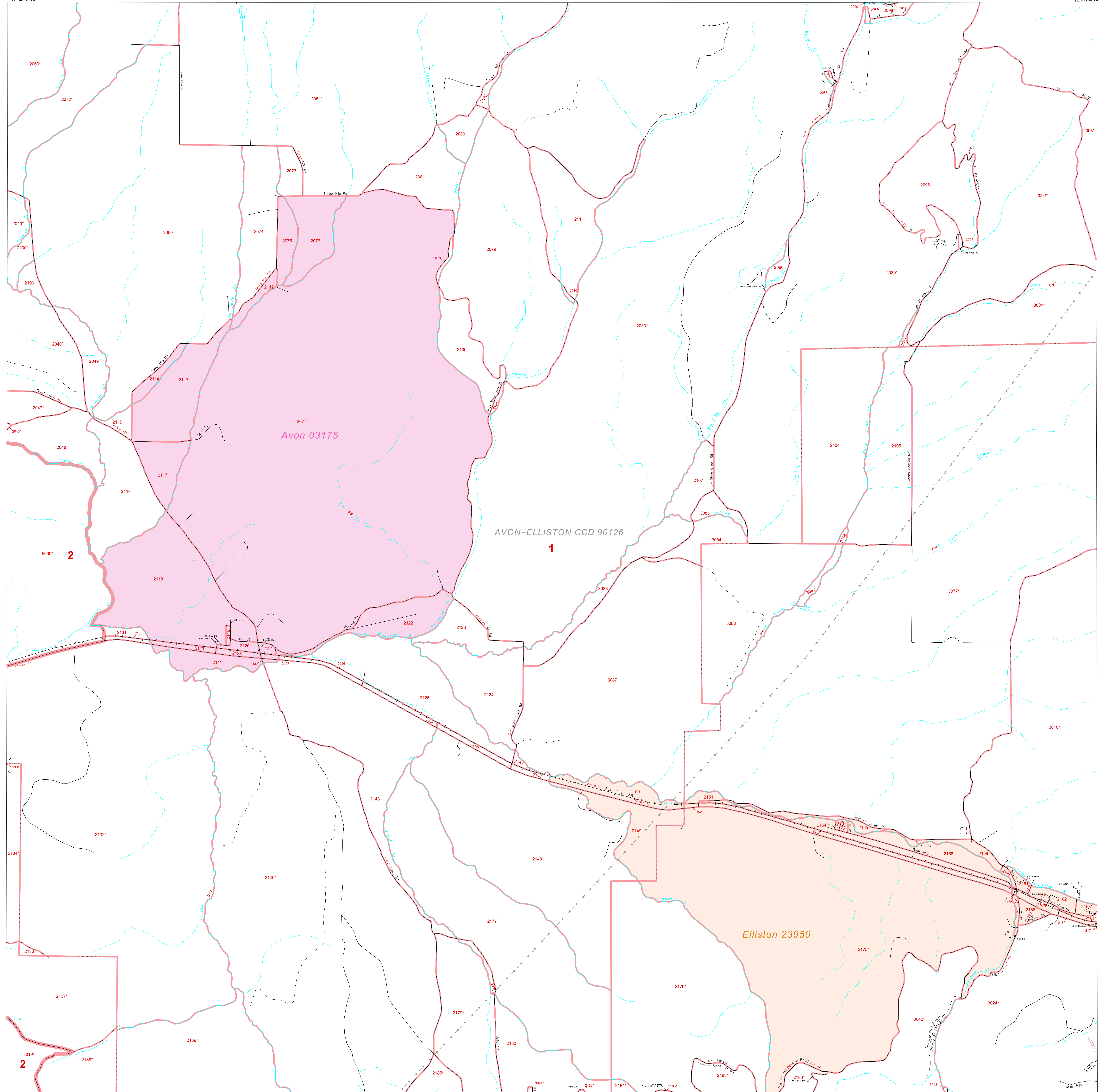


CENSUS 2000 BLOCK MAP: POWELL County
